The Sargent County Board of Commissioners met at 9:00 a.m. with the following members present: Steve Wyum, Bill Smith, Ray Brockman and Karen Anderson. Absent Donald Wehlander.

The meeting was called to order by Vice-Chairman Ray Brockman at 9:05 a.m.

Approve January 2, 2001 minutes. (Wyum/Anderson, unanimous)

Discussed the meeting of the Job Development Authority, which met on January 10, 2001. The JDA approved allocation of funds to Forman Development Corporation and Cogswell Community Club contingent upon availability of funding. The Board proceeded to discuss the JDA.

Concur with Forman City to approve applications for abatement of taxes for 1999 and 2000 from Harlan A. Klefstad Limited Partnership on Parcel No. 26-8327000 located in Forman. (Wyum/Smith, unanimous)

Lyle Bopp arrived at the meeting.

Gina Hillestad met with the Board to discuss the new premium deductible program with Worker's Compensation. The North Dakota Association of Cos. and the County Employer Group will pay the first \$100,000 of any claim. Early claims reporting will be critical and if any injury occurs and the county notifies them within 24 hours, a \$100 incentive for early reporting will be sent to the counties. The commission placed a call to NDACo for explanation of the new program. NDACo will be sending more information within the next two weeks and they plan to meet with the SE County Commissioners on April 5th.

Sandy Hanson presented an update of FEMA monies from 1998, 1999 and 2000 as of today. She explained some of the claims and the total approved for 2000 for townships is \$150,051.79. She asked permission to attend the Annual Emergency Management Workshop in Bismarck on January 30 through February 2, 2001. Approve attendance. (Wyum/Anderson, unanimous) She also noted that one commissioner is invited to attend with expenses paid. She reviewed the Emergency Management tasks for the First Quarter. Sandy reported there is a FEMA trailer available at a cost of \$500 and can be purchased for the county to use for emergencies plus for use during the fair. Approve purchase from Hazard Chemical fund. (Smith/Wyum, unanimous)

Tracey Anderson, Lake Agassiz Regional Council met with the Board to discuss the proposed schedule for a Sargent County Strategic Plan. This plan is mandatory to continue the eligibility of block grant funding in 2002. The purpose is to develop a vision statement and identify and prioritize issues at planning workshops. They would focus on economic development, housing, public facilities and public services. The Board will discuss this program and contact LARC at a later date.

Lyle Bopp left the meeting.

Approve omitted property assessment for Kelly & Kimberly Gruba on parcel No. 06-2272-001 on building assessment of \$71,656. (Smith/Anderson, unanimous)

Approve Permit 01-2001 to Cogswell Gun Club for a raffle on September 9, 2001. (Wyum/Anderson, unanimous)

Approve one-step increase effective January 2001 for all employees not at midpoint from contingency fund. (Smith/Anderson. Roll call: Wyum, Smith, Anderson and Brockman. Motion carried.)

Commissioner Smith introduced the following resolution and moved its adoption:

WHEREAS, the 2001 budget has earmarked \$150,000 for economic development to encourage and assist in the development of employment within the county, and

WHEREAS, the county commissioners approved formation of the Job Development Authority September 5, 2000, and

WHEREAS, the JDA has unanimously requested support and approval for a \$100,000 loan at 2% interest to JDA to purchase the only nursing home in Sargent County, located in Forman. Said loan shall be secured by a $2^{\rm nd}$ mortgage to JDA/Sargent County and administered by Forman Development Corporation,

NOW THEREFORE BE IT RESOLVED, the Sargent County Commission approves a \$100,000 loan at 2% interest under prime - (currently 9% - 2% = 7%) to the JDA to be administered by FDC.

Commissioner Wyum seconded the resolution. Voting Aye: Wyum, Smith, Anderson and Brockman. Voting Nay: None. Resolution was duly declared carried and adopted.

Commissioner Smith introduced the following resolution and moved its adoption:

WHEREAS, the Sargent County Job Development Authority has been approached by the Cogswell Community Club for funding, and

WHEREAS, said funding is necessary to complete the restaurant facility located in Cogswell, ND,

NOW THERFORE BE IT RESOLVED the Sargent County Commission approves a loan up to \$50,000 at 2% interest under prime (currently 9%-2%=7%) to be used as requested by the JDA for a restaurant facility in Cogswell. Said loan shall be secured by a 1st mortgage to JDA/Sargent County on the building proper.

Commissioner Wyum seconded the resolution. Voting Aye: Wyum, Smith, Anderson and Brockman. Voting Nay: none. Resolution was duly declared carried and adopted.

Steve Wyum left the meeting at 1:30 p.m.

Julie Hassebroek presented a letter of resignation from Marsha Mathias, Extension Support Staff effective February 28, 2001. Julie asked for consideration of hiring a replacement before Marsha leaves to assist with the training. This would allow for advertising the position the last two weeks of January 2001. The Board asked about the negative balance (\$2,328.66) in the Extension Service fund at yearend. Julie will check on some numbers and get back to the Board.

Sparky Engquist discussed the upcoming NDACE meeting in Jamestown on January 24-26 and also the purchase of a trailer from surplus property. Bridge 131-12.1 barricades are down and traffic is using it. This structure should be closed and abandoned. Instructed Sparky to check into blowing the bridge or else haul dirt to both sides and place structure closed signs on both sides.

Travis Paeper, Personnel Board Chairman, met with the Board to inform them of upcoming meetings on January 18th for employees to express concerns on the existing pay plan and job classifications. A questionnaire was sent to the employees for input at these meetings.

Julie H. arrived with some figures and questions on the budget showing a deficit. After further discussion it was agreed that a decision on this matter would be tabled until February 6^{th} .
