The Sargent County Board of Commissioners met at 9:00 a.m. with the following members present: Mike Walstead, Maurice Orn, Bill Anderson, Steve Wyum, and Jerry Waswick. Absent: none. Jacque Dotzenrod, the Sargent County Teller, was also present.

Approve minutes of January 5, 2010 meeting as corrected. Board members also received a copy of the year end financial report. (Waswick/Orn, unanimous)

Randy Gibbon, Milnor stopped by the meeting to inquire about commission districts and the upcoming election.

Damon DeVillers, Interstate Engineering, Inc. and Sparky Engquist, Road Supt, met with the Board to discuss second infrastructure (roads and bridges) Economic Recovery Package monies that are proposed at 75-100% of last monies that Sargent County received which was \$197,000. There are several road and bridge projects that would be eligible for these monies. According to Damon there are several state seal coat projects that are scheduled for this area. Discussion followed on which projects (bridge or road) that the Board should consider for submission. The Board instructed Damon to proceed with sending out letters for solicitation comments for two bridge projects and one road project. Also discussed the upcoming bid opening on January 29th in Bismarck for County #7 and #10. Mr. DeVillers also informed the Board that the bid opening for the crossing south of Rutland that washed out in 2009 is set for May 2010.

Board members requested information from Sparky Engquist regarding a bill for oil products, overtime for Jamie Lien and the bill for the Eagle Ditcher from Erickson Manufacturing, Inc. Sparky explained the use for the Eagle Ditcher and plans for future work. Motion that any capital assets for the Road Dept. from \$0-\$500 are at the discretion of the Road Supt., any from \$500-\$5000 the road commissioner will approve and any over \$5,000 shall have a motion by the entire Board of commissioners. (Waswick/Wyum, unanimous)

Sparky Engquist asked the Board about purchasing a new road grader. The road department has tried out a few machines and would like a 4 wheel drive without snow equipment that will have a ripper attachment. The Board instructed Sparky to get some price quotes and check into lease purchase options.

The Board reviewed an Application for Abatement and Settlement of Taxes for 2009 from Geraldine Hoffner, Fargo, ND for property described as a 6.66 acre parcel in the NW1/4-30-131-53 (Herman Township). The structure was destroyed by fire in May, 2009. The request is to remove the value of the structure for the eight months following the fire. Herman Township approved reduction of the valuation for 2009. Concur with Herman Township. (Anderson/Orn, unanimous)

Steve Hutcherson, Elite Heating and Air, Colfax, ND met with the Board to discuss the heating system in the courthouse. He provided quotes for two options – thermal storage units and propane fired boiler. Both proposals will have very little impact on the exterior façade and will be able to preserve the historical nature of the courthouse. The information provided is necessary to prepare an Energy Efficiency and Conservation Block Grant through the Department of Energy. Authorize the Chairman and Auditor to submit the grant application upon completion to the Department of Commerce before the February 12, 2010 deadline. (Anderson/Waswick, unanimous)

Appoint Sheriff Travis Paeper as Deputy Coroner as per the request from Lorraine Jacobson, County Coroner to fill the vacancy by the resignation of Shane Decker. (Anderson/Orn, unanimous)

Approve reappointment of James Bosse, Cogswell to the Sargent County Water Board. Approve appointment of Chris McFarland, Gwinner ND to the Sargent County Water Board to replace Dan Jacobson who is moving to Fargo. Both are terms of three years. (Wyum/Anderson, unanimous)
