The Sargent County Board of Commissioners met at 9:00 a.m. The following members were present: Jerry Waswick, Mike Walstead, Steven Wyum, David L Jacobson and Bill Anderson. Absent: None. Also present was Paige Cary, The Sargent County Teller.

Approve minutes of the January 7, 2014, commission meeting as revised. (Waswick/Walstead, unanimous)

David Ruch and Tia Bopp, Sargent County Fairboard, updated the commission on the 2013 fair and on improvements made to facilities at the Fairgrounds during the year. The net profit for 2013 was \$10,980. Money was spent in 2013 on repainting the grandstand and purchasing additional bleachers. Discussed: needed improvements to the rodeo arena; suggested improvements to the parking area; continued repairs planned for the Auditorium; required replacement and repair of beam supports in the grandstand; and, needed roof repairs to the Exhibit Building. The 2014 Sargent County Fair is scheduled for July 25, 26 and 27.

Sandy Hanson, Tax Director met with the commissioners to seek approval on the Soil Modifiers for Agricultural Property for 2014. Only one change was recommended from 2013 and that is to change the modification for Body of Water from a 50% reduction in valuation per acre on the soil type to a \$75.00 flat rate per acre valuation on the total acres identified, of at least 5 acre cumulative, minimum, per parcel. The modifiers as recommended are:

Sandy also reviewed the proposed 2014 County Average Value per all cropland acreage as set by the State Tax Commissioner. Preliminary numbers indicate that a valuation increase in the neighborhood of 7% may be required in order to keep the valuation within the guidelines required by State Law. More information will be provided to the Commission in future months, prior to the County Board of Equalization meeting. Sandy also reported that the residential sales have been reviewed by herself and Vanguard Appraisals. The 2014 sales in Sargent County are very strong, and the valuations on homes, for taxing purposes, are still, on the average, below the prices for which people are currently purchasing their homes, when compared to the market value average. Sandy, along with representatives from Vangaard Appraisals, compared some numbers as they are today, and found that the average is still below the current valuation. Weak points are the newer homes in the first ten years of depreciation. They also looked at the depreciation scale and found that older homes are possibly overvalued. More data will be prepared and presented at the next meeting.

Lyle Bopp, States Attorney arrived at this time.

Sparky Engquist, Road Supt. and Damon DeVillers, Interstate Engineering, Inc. met to review the proposed County Gravel Policy, Notice to Bidders and 2014 Gravel Bid Sheet. Several areas in the proposed policy were discussed and clarified for submitting bids for county purchases of gravel. It was recommended that the Contractors should be invited to a meeting to discuss the policy and ask any

questions that the Contractors may have on the changes. The Board agreed to carry over its decision on this policy until the February 4th meeting, and to invite the Contractors to the February 18th meeting for further discussion.

Damon DeVillers, Interstate Engineering, Inc. presented a proposal to supply engineering services for two projects. The Board proceeded to review and accept proposals submitted pursuant to Requests for Proposals for Construction Engineering services on the following projects: SC-4129(061)-PCN 20362 and BRC-4120(057)-PCN 19203. Interstate Engineering, Inc., Wahpeton, ND; Kadrmas, Lee and Jackson, PC, Valley City, ND; and Moore Engineering, Inc., West Fargo, ND were contacted for proposals. One proposal was received from Interstate Engineering, Inc. Accept the proposal. (Walstead/Jacobson, unanimous)

Damon DeVillers provided Change Order # 1 for Project CER-4103 (059), which was a Grade Raise, Riprap and Aggregate Base on County Road # 2 by Kraft Slough. The Change Order requested the increase necessary to the quantity of Borrow-Excavation and Riprap-Loose Rock to complete the project properly for an increase of \$131,888.27. Approve Change Order # 1 (Waswick/Anderson, unanimous)

The commission recessed for lunch.

The commission reconvened after lunch with Travis Paeper, Sheriff; Lyle Bopp, States Attorney; and Hans Hansen, Milnor present.

Melissa Blawat, Extension Agent, and Cindy Klapperich, Family & Consumer Science Agent, Agent stopped at the meeting to invite the commissioners to an upcoming Multi-County meeting with the 24th and 26th District Legislators and other area officials. This is an opportunity for the Extension staff to provide an update of activities in the Extension Office. The meeting will be held in Lisbon on March 3 from 9-12.

Hans Hansen, Milnor met with the commissioners to discuss some personal property that he alleges was stolen from him. Sheriff Paeper along with States Attorney Bopp agreed to assist Mr. Hansen with his concerns.

Travis Paeper informed the commissioners that due to the resignation of Derek Toepke, Deputy, effective January 6, 2014, Sheriff Paeper has advertised to fill the position, and the deadline for submitting applications is January 31. A committee will interview applicants after that date, as background checks are being submitted for completion upon receipt of the applications. Another deputy in the office is scheduled for medical leave on February 5th, and Sheriff Paeper is asking permission to hire off-duty deputies from neighboring counties to assist during the interim period, while hiring a new deputy and providing medical leave for another deputy. Authorize the Sheriff to hire Temporary Employees to assist until Deputy Bryant is back from medical leave or the new hire is on board. (Jacobson/Waswick, unanimous)

Lyle Bopp presented a revised Agreement, which he had prepared, between Marshall County, South Dakota, and Sargent County for the purpose of establishing rights and responsibilities of the parties concerning a bridge physically located within the boundaries of Sargent County, on the state line, which had been carried on the bridge inventory of both Counties for many years. The bridge is described as SC Bridge # 136-24.1 and Marshall County Bridge #46-334-000. Motion to authorize the Chairman and County Auditor to execute such agreement. (Anderson/Walstead, unanimous) A complete copy of the agreement is filed in the bridge report file.

Approve reappointment of James Peterson, Rutland and Raymon Nelson, Milnor to the Sargent County Park Board. (Anderson/Jacobson, unanimous)

Jerry Waswick asked if sand could be placed on the road south of Cayuga where the experimental soy-oil based gravel stabilizer had been applied last summer, as it is very slippery at times following snow and icy conditions. It was noted that there are other areas that also could use some sand and Mike Walstead will contact Sparky Engquist regarding this request. Jerry also indicated that he would like to see a map of the county, indicating which roads are intended to be graveled in 2014, to review prior to the bid letting, and also requested that a letter be sent to all contractors who have stockpiled gravel for the county to verify the audits of gravel inventories that were completed by the Auditor's Office in late 2013.
