Approve request for amendment for Hillside C-Store reducing approved budget from \$30,000 to \$22,204.15.

Sandy Hanson, EMS, met with the Board and explained that Forman City has applied for funding to replace water and sewer lines. They have applied for a grant for a diversion around the southwest side of Forman City. There is much concern about downstream landowners. Sandy presented an update on 1998 disaster claims and will contact the townships of money that is available. She will attend a 2 1/2-day session on terrorism in Bismarck that will deal with school terrorism action. She will meet with the local schools after that meeting. In November a mass fatalities response course will be presented in Bismarck. She set up a work plan for the year 2000 and will review with officials when she is in Bismarck. Approved DSR's for 1999 were delivered to the Forman City, Gwinner City, Silver Lake, Forman pool and some of the township. The townships for 1999 disaster have turned in approximately \$233,000.

Steve Wyum suggested that the Personnel Board review the EMS-911 position and make a recommendation to this Board.
