The Sargent County Board of Commissioners met at 9:00 a.m. with the following members present: Karen Anderson, Ray Brockman, Mike Walstead, Steve Wyum and Don Wehlander. Absent none.

Norm Preble, Tax Director, and the Board set appraisal valuations on county lands and lots forfeited to Sargent County for non-payment of taxes. Moved to approve appraisals. (Wehlander/Anderson, unanimous) A list of property and appraisals will be posted at the front door of the Courthouse on November 4, 2004. According to law, the time of hearing objections to the minimum sales price agreed upon was set for 10:30 a.m. on November 4, 2004. Discussed the property located in Cayuga owned by Rutland-Havana Farmers Co-Op Elevator Company. Motion to direct the auditor not to proceed with a tax deed for Parcel No. 30-9267000 (42,120 Sq. ft) (Brockman/Walstead, unanimous)

Sandy Hanson, EMS, informed the Board the County Terrorism Annex was approved by the state on 10-5-04 and \$6000 transferred to the county for Homeland Security. She discussed the list of grants totaling \$96,000 for HS equipment for various agencies in the county. Sandy presented the annual EMS performance application for the new fiscal year. Sandy's employment status was discussed and she reported on the future of HS and the Terrorism Annex. Discussed Sandy's full-time status and agreed to extend for another six months and review at that time. She will work on the application for funding reimbursement and meet with the Board at the next meeting.

Gerald Dill, Lysle and Gerald Coleman, Verner Township met with the Board to discuss a dust problem on roadways and the two miles of roadway that connects with Dickey County. Gerald Dill, Chairman, Verner Township, asked the county to maintain this road because it is so costly to gravel. Lysle Coleman reported that Dickey County wants to make a Federal Aid Road of their section of roadway and he wondered if Sargent County would consider adding this to the FAR system. Dickey County has not contacted this Board with any proposal. The commissioners informed those present that the county road budget had to be cut for 2005 because there is a shortage of funds. There may be additional federal funds but they have not been approved at this time. Mr. Dill suggested a commodity tax for additional revenue. The Board feels the state needs to come back to the county with more money. The Board is trying a project east of Rutland that might work on the two miles. Also discussed installing speed limit signs to reduce the speed of the truck traffic. Another concern is the dust problem along County No. 1 by Lysle Coleman's and he would like some solution to eliminate any accidents from the trucks/dust problem. Following a lengthy discussion, Steve Wyum reported that NDDOT has been contacted about doing a pilot project on asphalt alternatives and they were favorable. There is some opportunity that the county can work on this problem but the roads must meet federal specifications before any funding would be allowed. The Board agreed to schedule a meeting on February 15, 2005 with the township to discuss costs and suggestions for township participation.

Bob Adermann, road department, reported that 60% of the County No. 4 project is complete, and the road crew is sweeping the mud off the roadway when it gets wet. Road graveling is almost complete for the year and the Rutland-east project needs one more seal coat. Work on County 10 two miles north of Rutland is scheduled to begin later this month. Bridge projects are also scheduled for repair next month.
