Approve removal of the following items for surplus property: #2746-HP Fax machine and HP Scanner and offer for sale at next county auction. (Anderson/Wyum, unanimous)

Motion to place the 1991 Ford F150 pickup (VIN-11854) in surplus property and offer it for sale at the next county auction. (Anderson/Wyum, unanimous)

Grant permission to the County Treasurer's Office to write off three uncashed checks that are more than two years old. (Check No. 27063, dated 9/3/07 to Worldwide Recording for \$10.00, No. 27219, dated 2/14/08 to Steven Murdock for \$93.47 and No. 57984, dated 9/28/07 to School Kids Healthcare for \$600.00. (Waswick/Anderson, unanimous)

The hearing on appraisals of property forfeited to the county for delinquent taxes was opened at 10:00 a.m. Sandy Hanson and Shannon Jablonsky, Tax Director's Office arrived at the meeting. Mark Bopp, Mayor, Forman City indicated that the city is interested in purchasing the two forfeited properties located in Forman. Discussion followed on all the properties. Motion to approve the appraisals as revised and direct the States Attorney to send eviction notices to all occupied properties. The hearing was closed at 10:30 a.m. (Waswick/Anderson, unanimous). The public auction for sale of this property is scheduled on Tuesday, November 16, 2010, at the office of the County Auditor beginning at 1:00 p.m. The list of property to be sold will be posted at the front door of the Courthouse.

Sandy Hanson reviewed the answers to questions she researched regarding the Vangaard Appraisals, Inc. contract. Discussed liability insurance and service contracts as well as installation/training hours included with the initial purchase of software modules. Motion to authorize signing and executing the Vangaard Contracts based on items reviewed and States Attorney approval. (Wyum/Anderson, unanimous)

A hearing for an Abatement or Refund of Taxes was conducted on Lot 8, Block 5, Original Addition, Gwinner City for 2010 taxes. Request from Gerald W. Waswick to reduce the value of the building improvement from \$26,096 to \$17,136 for the five (5) year new building exemption that was approved by Gwinner City but not applied. Gwinner City approved the abatement. Concur with city. (Orn/Anderson, unanimous, with Commissioner Waswick abstaining from the discussion and vote)

Sparky Engquist, SC Road Supervisor; Damon DeVillers, Interstate Engineering, Inc.; Lysle Coleman and Jerry Dill, Supervisors of Verner Township met with the Board. The Verner Township Board members are concerned about County Road 2 and the use of the parallel township road as a haul road and detour route when the county road was closed for a week due to high water in Kraft Slough. They are requesting 25-30% of the gravel cost for repairs to the roadway three miles north of the county road. Sparky indicated that it is standard procedure to make repairs to roadways that were used as

detours in the county. The ER project could allow monies for haul road restoration for repairs. Sparky was directed to work with the township to obtain haul road restoration funding.

Damon DeVillers reported that his staff is working on an estimate of the cost for right of way survey on the portion of County #4 that is situated on the old Cogswell-Brampton railroad right of way. He also discussed the Federal highway bill, and the fact that a new one is not expected to be passed for two years. The FHA is approving money month to month pursuant to a Congressional continuing resolution, so funding for new road projects is very limited. There are also some extra Bridge Funds available because a number of North Dakota counties do not have matching funds available to take advantage of the Federal funding and only one bridge is on the county list at this time. Bridge No. 135.05 over the Wild Rice in Hall Township has a 2012 bid date and will take some additional time and work to get ready for bidding due to wetland issues. Another bridge suggested is the 123-20 This site requires no grade located on County #5 between Section 11 and 14 of Weber Township. raise and has no known wetlands or archeological issues. Damon will work on plans and specifications to replace the old bridge with a box culvert. Bills for Emergency Repair work for 2009 are due for submission to the state—all invoices and paper work should be sent in ASAP. Sparky will take care of this. Damon also discussed the Title VI Compliance Guidelines. Title VI is part of the Civil Rights Act of 1964. Non-compliance will change how funds and reimbursement to counties will be handled. Damon will provide the paper work for Title VI Compliance to the county and work with ND Dept. of Transportation and other counties to meet compliance guidelines.

Sparky Engquist reported that the milling on County Road 12 and 14 is done and the road employees are working on the sub-grade until freeze up. Discussed the perceived problem of over weight trucks damaging County and Township roads and possible enforcement methods. Commissioner Orn suggested coordinating with the Sargent County Sheriff's Office to deter speeding and weight violations on County roads. FEMA project deadline is Friday, October 22, for submission of projects for reimbursement.
