The Sargent County Board of Commissioners met at 9:15 a.m. with the following members present: Jason Arth, Lyle Bopp, Mark Breker, Richard Ruch and Jerry Waswick. Also present was Pam Maloney, Sargent County Auditor. Mary Engst, Sargent County Teller, was present through technology.

Chairman Lyle Bopp called the meeting to order.

The Pledge of Allegiance was recited.

Motion to approve the agenda as amended. (Arth/Waswick) Motion carried unanimously.

Some discussion was held on the Gallagher Market Study that was done for the Road Department. There will be a TEAMS meeting Thursday morning, October 21 at 8:00 a.m. to discuss this with Mr. Mike Verdoorn. The board was not satisfied with the report as they used two year old data and the counties used in the comparison were much larger counties.

Motion to approve out-of-state travel for two road department employees to attend a conference in South Dakota. (Arth/Waswick) Upon roll call vote, motion carried unanimously.

The parking lot has been put on hold until the tiling can be done.

Commissioner Breker stated that the Personnel Board would like to be more involved with new/reviewed policies that the commissioners make. In the future, policies will be referred and reviewed by the Personnel Board before adoption.

Motion to approve the October 7, 2021 minutes as presented. (Waswick/Breker) Motion carried unanimously.

Jayne Pfau, State's Attorney, arrived at the meeting at 10:58 a.m.

More discussion was held on the Cellular Phone Reimbursement policy. Motion made to amend the cell phone policy to reimburse the county commissioners \$25/month (half reimbursement) effective October 1, 2021. (Waswick/Ruch) Roll Call Vote: Yes – Bopp, Breker & Waswick. No – Arth & Ruch. Motion carried.

Motion to pay off the excavator with Cares Act Funding. This money is available to be used at the commissioner's discretion and is not limited to Covid concerns. (Arth/Waswick) Upon roll call vote, motion carried unanimously.

Commissioner Breker gave a brief report on the Crooked Creek Watershed Study informational meeting that he had attended.

Jill Mulder, Human Resources Director, arrived at the meeting.

There was some discussion on whether the Treasurer/Recorder/Clerk of Court job description should be looked at, as the Human Resources Director is now the risk manager, which had previously been a duty of that position. The job descriptions are looked at as a whole and the pay scale is not based on individual duties or jobs, so it is unlikely that there would be a change in the pay grade of the Treasurer/Recorder/Clerk of Court.

Commissioner Breker asked what an employee should do if they are having an issue with the Human Resources Department. The employee should contact the commissioner holding that office's portfolio and together they would approach the Human Resources Department. If the problem persists, it would come before the full board of commissioners.

The NDACo/NDCCA County Tour will be coming to Sargent County on Wednesday, October 27 beginning at 1:00 p.m. and lasting approximately two hours. The purpose of the County Tour is to

increase communications among county officials, NDACo and NDCCA; to hear county concerns and answer any questions the county has about the services and programs the organizations provide.

The commission proceeded to set minimum sales prices on lands and lots within Sargent County forfeited to Sargent County for non-payment of taxes. Eight new parcels were appraised and five parcels that had been forfeited to the county in previous years were re-appraised. Motion to approve appraisals and minimum sales prices set, excluding Parcel #04-1591000 pending further research. (Arth/Breker) Upon roll call vote, motion carried unanimously. The time for hearing objections to the minimum sales price agreed upon was set for 9:00 a.m. on Tuesday, November 2, 2021. A list of properties and appraisals will be posted at the front door of the courthouse by Tuesday, November 9, 2021, and the properties will be offered for sale on Tuesday, November 16, 2021 at 10:00 a.m.

State's Attorney Pfau arrived back at the meeting after researching the parcel mentioned above. Motion to proceed, upon the state's attorney's recommendation, with tax deed proceedings on Parcel 04-1591000 and to send another letter to the affected landowner. (Waswick/Arth) Upon roll call vote, motion carried unanimously.

Motion to authorize the Chairman and the Auditor to sign the Certification of Local Match for Bridge Inspection/Load Rating for the ND DOT. (Waswick/Arth) Upon roll call vote, motion carried unanimously.

Approve October payroll in the sum of \$215,378.61 (Nos. 19724-19781 & 82671-82678) and the following bills. (Waswick/Arth). Upon roll call vote, motion carried unanimously.
