Bill Anderson reported on the Veteran's Service Officer (VSO) replacement process in which Sargent County is cooperating with Ransom County. A selection committee composed of 2 Commissioners from Sargent County, David Jacobson and Bill Anderson, 2 Commissioners from Ransom County, George Bunn and Neil Olerud, and Ransom County States Attorney Fallon Kelly, reviewed 10 applications on October 30, and recommended 6 applicants to be contacted for interviews. Four applicants submitted documentation evidencing that they were entitled to "Veterans' Preference" pursuant to North Dakota State law, and were interviewed on November 13th at the Ransom County Courthouse with Commissioner Steve Wyum filling in on the Committee for Commissioner Jacobson. The Committee, by a unanimous vote, recommended that Mr. Jon Hanna, Lisbon be hired for the position. The Ransom County Commission will be acting on this recommendation at its meeting today. If he accepts the VSO position, Mr. Hanna will be an employee of Ransom County, with Sargent County contracting for ¼ of the VSO's services and expenses.

Lyle Bopp, States Attorney arrived at the meeting at 9:45 a.m.

Damon DeVillers, Interstate Engineering, Inc. and Sparky Engquist, Road Supervisor met with the Board to discuss road issues. Damon distributed several draft project concept reports for permanent repairs to road and bridge projects eligible for federal funding as part of the County's Federal Aid System (FAS). Discussion and comments will be continued at the December 4 Commission meeting at 9:30 a.m. The Board next proceeded to discuss encroachments on road rights of way on both FAS and non-FAS roads, and the desirability of adopting a comprehensive, coherent policy for dealing with encroachments. Motion to have the Road Supervisor, States Attorney, Road Commissioner and County Engineer draft a formal policy dealing with independent work on road rights of way and other encroachments, including farming, ready to review by the second meeting in February, 2013. (Wyum/Waswick, unanimous)

Motion to authorize the Chairman, States Attorney, County Auditor and Highway Supervisor to execute a "Maintenance Certification" certifying to the North Dakota DOT that, in Sargent County, all federal aid highway projects have been inspected; are being maintained in a good and safe condition for general public use; and, that maintenance is in accordance with the NDDOT "Construction and Maintenance Agreements". (Jacobson/Walstead, unanimous)

Discussed possible sites to submit for consideration for federal funding for improving safety at railroad-highway grade crossings. Federal funds would cover 90% of the actual cost of the project and the remaining ten percent would be the responsibility of the county. Instruct the Road Commissioner; Road Supervisor and County Engineer to submit a list of hazardous or dangerous crossings to the state for consideration of crossing improvements.

The Board recessed for lunch at noon.

The Board reconvened at 1:00 p.m.

The Annual Tax Sale was conducted at 1:00 p.m. Properties were auctioned individually and sold to the highest qualified bidder thereon. Motion to accept bids and approve the following deeds. Lots 17-18, Block 5, Brampton Village to James W Bosse, Cogswell, ND for \$75; Lots 1-2 and North Seventeen feet (17') of Lot 3, Block 46, First Addition, Forman City to Forman City, a municipal corporation for \$1138; Lots 16-17, Block 7, Original Addition; East 1/2 of Lot 1, Block 4, McNeeley's Addition and West 100 feet x 150 feet of Lot 1, Block 8, McNeeley's Addition all in Cogswell City to Cogswell City, a municipal corporation, Cogswell, ND, for \$299, \$389 and \$520 respectively. (Waswick/Jacobson, unanimous) Lyle Bopp was instructed to send eviction notices to anyone who is still occupying property that is retained and owned by Sargent County.

Motion to authorize the County Auditor to sign the 2013 Master Support Agreement and addendum with NRG Technology Services, Bismarck. (Jacobson/Wyum, unanimous)

The Board reviewed the results of the Official Canvass of the November 6, 2012 General Election. The following were elected to the respective county offices: County Commissioner at Large – Bill Anderson – 1226 and Jerry Waswick – 1315; Supervisor, Wild Rice Soil Conservation District – Bruce Speich - 1728; Director, Garrison Diversion Conservancy District – Jeff Breker - 1697. Total votes cast in the county 2037. Accept results. (Walstead/Jacobson, unanimous)
