The Board received a letter from Attorney Andrew Forward informing them that his client Dean Schmit of Oakes, ND has decided to withdraw his Petition to Close the Section Line between Section 28 and 29-130-58.

Authorize Chairman to sign the Court Facilities Improvement Advisory Grant and submit as soon as completed by Courthouse Commissioner Walstead and area contractors. (Anderson/Orn, unanimous)

Marwood Klein, Forman Ambulance Coordinator and ambulance personnel from Premier Specialty Vehicles, Inc., Fergus Falls, MN and M & T Fired Safety, Inc., Volga, SD arrived at the meeting.

States Attorney Lyle Bopp arrived at 10:05 a.m. Lyle informed the Board \$910.80 of forfeited drug money had been returned to the county from the ND Attorney General's Office and deposited in the county General Fund.

The Board proceeded to open bids for one new ambulance for the Forman squad. Sherry Hosford, Auditor informed the Board that another ambulance dealer had called on the afternoon of Monday, December 15, and stated that the blizzard of Saturday and Sunday had not allowed him to deliver the bid. He was sending his bid by UPS overnight. Upon a phone call to the dealer, he informed the Auditor that the bid had been sent and currently was somewhere in ND. Commissioner Anderson noted that the advertisement for bids specified that bids would be opened at 10:00 a.m., that other bidders had coped with the same blizzard and delivered bids at the time specified, and made a motion to proceed with the ambulance bid opening and that any late bids received be returned unopened to bidder. Commissioner Waswick seconded the motion. Roll call: Aye: Walstead, Anderson and Waswick. Nay: Orn and Wyum. Motion carried. Lyle Bopp opened the bids and viewed the bidder's bonds and Sherry Hosford read each bid. The Board asked that Marwood Klein, Ambulance Coordinator review each bid and make a recommendation to the Board at 9:00 a.m. on January 6, 2009.

Marwood Klein asked the commission about any uncompleted work and unexpended funds remaining on the initial contract that was extended to him upon his employment with Sargent County. Commission Chairman Steve Wyum stated that the Board will look into this contract.

Lyle Bopp presented the updated Police Services Contract between City of Milnor and County of Sargent. Authorize the Chairman, Auditor and Sheriff to sign said contract. (Waswick/Anderson, unanimous)

Sandy Hanson reported to the Board of upcoming emergency drills. She discussed 2005 FEMA monies, administrative fees and late paperwork. Sandy asked Jerry Waswick to update the Board on the recent soil study workshop that was presented in Bismarck. Several members of the Sargent County Soils Committee also attended the class. Jerry thought that it was a good class but feels that the first step is to get the committee activated and get organized. Jerry would serve as a liaison member of the Board and was informed that it will take three years to complete the soils study. This committee will look at soils each year and make many decisions on several issues. Sandy would like to get more information and suggested deciding on term for Board members and also per diem.

The Board proceeded to review an Application for Abatement or Refund of Taxes from John A Nicolai on Lots 21-22, Block 26, Original Addition, Milnor City. Mr. Nicolai is requesting a reduction in the building value as he qualifies for exemption as 80% disabled veteran. Milnor City approved the abatement. Concur with city. (Anderson/Orn, unanimous)

The Board recessed at noon for the Employee Potluck Christmas Dinner.

Sparky Engquist, road Supt. met with the Board and requested purchasing another tandem plow truck with a sander and underbody scraper. He is looking at Boyer Trucks in Savage, MN at a cost of \$25,900-\$29,900. Sparky plans to go to Savage and test drive a truck. Authorize Road Supt. to purchase a tandem plow truck, with option to trade-in one of the current trucks subject to approval from road commissioner not to exceed \$30,000. (Walstead/Waswick, unanimous) He also suggested that the Board be considering purchasing another grader in 2009. There are several lease options available for new or used machines with options to trade-in our current machines. Discussed a culvert on County # 2 between Section 11/12-130-58 that had planned to be replaced. After inspecting the site Sparky determined the culvert was in good shape and only cleaned out both ends. Sparky also discussed the temporary employee position with the possibility of fulltime in the fall of 2009. Sparky

talked to former temporary employee who can help out this winter in the absence of a current employee. Approve wage at \$12.50 per hour.
Julie Hassebroek, Ext. Service met with the Board to explain a travel bill.
