Approve minutes of the December 4, 2012, commission meeting as corrected. (Waswick/Walstead, unanimous) Board members also received a copy of the November 2012 financial statement.

Lyle Bopp, States Attorney arrived at this time.

Sandy Hanson, Tax Director/911 Coordinator/Emergency Manager arrived at the meeting.

Brian Orn met with the Board regarding a hearing on his Abatement Application for a structure that was removed in 2011 on Sublot 2 of the NW1/4 28-132-57. He is requesting the reduction of taxes for removal of the structure for 2012. Vivian Township approved the application. Concur with the township. (Wyum/Anderson, unanimous)

Sandy Hanson inquired of the Board about her request for a 40 hour work week. The 2013 budgets reflected the 35 hour week, with a contingency fund set up for additional hours, if approved. Commissioner Jacobson requested that the department heads submit a month by month analysis of the need for additional working hours to the Board for review and consideration.

Sandy Hanson also informed the Board that North Dakota is currently working on a mapping system for responders. NDDOT has flown about 80% of the state, taking photos of all roadways and marking centerline points so there is a consistent mapping system throughout the state. NDDOT is also marking each structure with the 911 address. Sandy will work with GEOCOM to complete the Sargent County maps. GEOCOM representatives will be in the county reviewing the area to be certain that all the information is correct.

Lyle Bopp presented to the Board an Agreement for Road Maintenance on a portion of a township road in Weber Township described as the sole access route to a residence located in the SW1/4-32-129-54, in the southeastern corner of the Township. Weber Township has requested that the County maintains such road on behalf of the Township, and in furtherance thereof the parties have agreed to the terms of the draft maintenance agreement, which is attached to these minutes. Motion to approve the agreement, with corrections. (Wyum/Walstead, unanimous)

Jerry Waswick reported that the Soils Committee for the county is scheduled to meet on Wednesday, December 19<sup>th</sup> at 8:00 a.m. to review the values, modifiers and other information for submission to the commission. Upon review and approval by the Commission, the County's plan for implementation of

the soils based valuation system for agricultural property will be submitted to the North Dakota State Tax Department for final review and approval.

The Board recessed at 11:45 a.m., and proceeded to the 2<sup>nd</sup> floor conference room for the Annual Employee pre-Christmas Potluck Dinner.

The Board reconvened at 1:00 p.m. with Damon DeVillers, Interstate Engineering. Inc and Sparky Engquist, Road Supervisor present.

Damon DeVillers reviewed an updated list of 2010 and 2011 Emergency Repair projects in the county with estimated costs and eligible reimbursable dollars. Approved permanent repairs at ER sites on FAX County Roads are eligible for 80% cost share from the Federal government with a 20% local match. Several ER project sites were combined with other ER sites because they are logically connected to each other and to simplify the process. Nine projects were reviewed and considered. Board members discussed each project and set priorities and approved submission of the Project Concept Reports for these projects to NDDOT for their consideration of funding. (Walstead/Wyum. Roll call: Aye: Walstead, Anderson, Waswick and Wyum. Nay: Jacobson. Motion carried)

Motion to authorize the Chairman and the County Auditor to execute the Engineering Contracts for the following projects: CER 4129(058); CER 4125(063) and 4118 (054). (Anderson/Waswick, unanimous)

Sparky Engquist informed the Board that he has requested the use of another tractor from Titan Equipment under the lease program and requests authority to purchase a snow blower for use with the tractor. A 2011 Luken snow blower has been offered to the county for \$6,500 by Jamey Lien. The price of a new snow blower of the same make and model is approximately \$9,500. Discussion followed on buying new versus used. A motion to offer Jamey Lien up to \$6,500 for the snow blower, subject to inspection and approval by the Highway Supervisor and the Road Commissioner. (Wyum/Walstead. Roll call: Aye: Wyum, Anderson and Walstead. Nay: Waswick and Jacobson. Motion carried)

Authorize Commissioner Waswick to complete the grant for Court House Facilities and Improvements and submit to the state prior to the December 31, 2012 deadline. (Walstead/Anderson, unanimous)
