Sheriff Travis Paeper joined the meeting at this time. He is proposing a 4 day work week at the Courthouse during the summer months. He proposes to implement it within the Sheriff's department, however, he stressed the proposed summer hours would only affect hours in the office, and would not affect the shifts worked by the Sheriff and the deputies. The offices would be open from 8 am to 5:30 pm Monday through Thursday and closed on Fridays under the schedule proposed by the Sheriff. The commission requested that he discuss the proposal with all department heads, & suggested that the proposal could be discussed at the non-agenda employee meeting on April 2nd.

Sandra Hanson, Tax Director, joined the meeting at this time. Three Applications for Abatement or Refund of Taxes concerning property owned by Joe Aberle and situated in the Milnor Renaissance Zone were presented. 2012 real estate taxes on these properties had been inadvertently omitted from the Renaissance Zone tax credit. Milnor City had approved the request for the abatement of taxes on these properties for 2012. However, the commission had further questions regarding the applicability of both the 2 year "New Home" tax exemption and the 5 year Renaissance Zone property tax exemption and tabled consideration of the applications until the April 2nd meeting, pending receipt of the opinion of the States Attorney. The property qualified for a wheelchair/blind exemption for 2012. Milnor City had approved the application. Concur with the city to approve the abatement for parcel 25-7791000, Lot 25, Block 2, Park Lane Addition, Milnor City. (Wyum/Waswick, unanimous)

The Chairman was authorized to sign the multi-hazard mitigation grant application as prepared by Sandra Hanson, Emergency Manager. (Anderson/Wyum, unanimous)

Discussion on a possible revision to Section 310 of the Sargent County Personnel Policy regarding an employee's use of sick leave when caring for family members who are not members of the employee's household and are not dependants of the employee. The matter was referred to the Personnel Board with the request to have a recommendation at the next meeting. (Wyum/Walstead, unanimous).
