The Sargent County Board of Commissioners met at 10:00 a.m. following the meeting of the Sargent County Park Board. The following members were present: Jerry Waswick, Mike Walstead, Steven Wyum, David L Jacobson and Bill Anderson. Absent: None. Also present was Paige Cary, of the Sargent County Teller.

Motion to approve the revised draft of the minutes of the April 1, 2014, commission meeting with the exception of the last paragraph, which should read: "Commissioner Walstead reported that he had given two road department employees permission to use the County road department vehicles for personal use". (Jacobson. Died for lack of a second). Motion to approve the revised minutes of the April 1, 2014, Commission meeting. The last paragraph reads: "Commissioner Walstead reported that he had given two road department employees, Sparky Engquist and Virgil Nogowski, permission for overnight use and possession of the County road department pickup trucks, away from the County shop, for County Road Department purposes." (Walstead/Waswick. Motion carried)

Lyle Bopp, States Attorney, arrived at 10:15 a.m.

Melissa Blawat and Cindy Klapperich, Extension Office, presented the Quarterly Reports for the first quarter ending March 2014, to the commission. Handouts were provided to the commissioners. The Commissioners thanked Ms. Blawat and Ms. Klapperich for the thoroughness of their reports, and for the excellent work being done by the County's Extension Service personnel.

Sandy Hanson, Tax Director, presented an Application for Abatement or Refund of Taxes which had been filed by Jeff and Donna Anderson, Gwinner on Lot 3, Block 1, Springs Addition, Gwinner City to request a 2-year new home exemption for 2013 and 2014. The exemption had been approved by the city and had been inadvertently omitted from the 2013 tax exemptions. Gwinner City approved the abatement. Concur with the city. (Anderson/Walstead, unanimous)

Jim Hill, RDO Equipment Co., Fargo; Kevin Sikich, Butler Machinery, Inc., Fargo and Sparky Engquist, SC Road Supt. arrived at the meeting. Road Commissioner Mike Walstead and Road Superintendent Sparky Engquist made a recommendation to the Board to accept the bid from RDO Equipment to lease with option to purchase two 2014 John Deere 672G motor graders – one with snow equipment and one without the equipment. Discussion followed on trade-ins and purchase agreement and bid specification on service brakes. Motion to enter into a lease agreement with RDO Equipment Co., for 2 John Deere Motor graders one with snow equipment and one without the equipment with a trade-in on the 2002 Volvo motor grader and the 1996 John Deere motor grader. The lease option will cost approximately \$41,317/year for 4 years plus a balloon payment at the end of the four years if the option to purchase is exercised at that time. (Anderson/Walstead. Roll call. Aye: Anderson, Walstead, Wyum. Nay: Jacobson and Waswick. Motion carried)

Sparky Engquist reported on repairs to the county track hoe. The 1996 Komatsu Track hoe needs a bearing replaced and the cost with DMI, Aberdeen to make the repairs is between \$14,000 and \$16,000. To purchase a like machine that is ten years newer would cost about \$50,000. Motion to proceed with repairs to the track hoe. (Walstead/Anderson. Roll call: Aye: Waswick, Anderson, Walstead and Wyum. Nay: Jacobson. Motion carried)

Road department employee timecards were discussed. It was questioned why some are not punching in and out on the time clock each day and, instead, writing the times on their cards. The Road Superintendent explained that when an employee will be working on a project that is nearer to his home than to the County Shop, the employee can be at the job site sooner and work at the site longer, if he leaves from his home in the morning and returns to his home in the evening without going to the County Shop to punch in and out. Also questioned the Road Superintendent as to why county equipment, including: a motor grader; the chip spreader; a road packer; and, a road disc; is parked at various locations all over the county and not back at the shop for maintenance, repairs if needed and storage. Road Superintendent Engquist stated that heavy-duty, hard to transport items are often left at or near the location of the next job on which they will be used, and that the Road Department had obtained permission from Edwin Erickson to park a motor grader in the Erickson farmyard, and that it was parked there to save travel time to and from gravel roads in the northeast quadrant of the County. It was the understanding of the Commission that County equipment would be brought back to the shop if it is not to be used on a road project within a short time, days or weeks, but not months.

Approve appointment of Joan Lee, Cayuga as the Inspector of Elections for the June 10 and November 4, 2014 Primary and General Elections. (Waswick/Jacobson, unanimous)

Reappoint Harris L. Anderson, Havana and Tammy L. Nelson-Mathews, Cogswell to five year terms on the Sargent County District Board of Health. (Jacobson/Anderson, unanimous)

Motion to rescind a motion made at the March 20, 2014 meeting regarding including a measure on the Primary Election ballot for property tax exemptions and to replace the rescinded motion with a motion to include the ballot language on the November General Election ballot pursuant to the requirements imposed on counties and cities with a population under 40,000 by the 2013 State Legislature. (Walstead/Anderson, unanimous)

The county Deferred Compensation Plan contains some outdated information and needs to be updated in order to reflect recent changes in IRS regulations concerning deferred compensation. Lyle Bopp also inquired about Roth IRA's through the Deferred Compensation program. The Board referred the matter to the County Personnel Board to review the current plan, current IRS requirements and whether Roth IRA's could or should be included in the County's plan, and, to make a recommendation to the county commission concerning necessary or desirable changes for the County's plan, if any.
