The Sargent County Board of Commissioners met at 9:00 with the following members present: Wade Anderson, Jason Arth, Lyle Bopp, Mark Breker, and Scott Johnson. Also present was Bob Banderet & Jerry Waswick, county residents; Tia Bopp, Auditor's Office and Pam Maloney, County Auditor.

Chairman Scott Johnson called the meeting to order.

The Pledge of Allegiance was recited.

Motion to accept the agenda as amended. (Anderson/Arth) Motion carried.

Motion to approve the April 2, 2024 meeting minutes. (Bopp/Anderson) Motion carried.

Duane Peterson, Human Resources Director, arrived at the meeting.

Melissa Seykora, NDSU Extension Agriculture and Natural Resources (ANR) Agent, arrived at the meeting and reported on her activities in the County's Extension Service office from January through March of 2024. A written report was delivered to each commissioner and to the county auditor. A copy of the report can be obtained from the Extension Office. Ms. Seykora had worked with numerous projects including: taught a hands-on lesson about farm financial statement basics and farm safety hazards and gauges at Annie's Project in Dickey County; taught a module at the Design Your Succession Plan in LaMoure County; coordinated the southeast crop market update meeting in Forman; 4-H Communication Arts Contest and held three different private applicator pesticide trainings. She has also participated in an Extension Advisory Council Meeting; Fair Board and SCD Meeting reports; 4-H Council meeting and 4-H STEM specialist search committee member. Moving forward she will be involved in Stop the Bleed Training; Progressive Agriculture Safety Day; Plant Auction; 4-H Consumer Decision Making Contest; REAL Colors Facilitator Training & the Sargent County Fair. The commission thanked her for her service and dedication to the public.

Jayne Pfau, State's Attorney, arrived at the meeting.

After researching the purchase of grass seed from other vendors, the custodian would like to order grass seed from Twin City Seed at a cost of \$2.50/pound with a total cost of \$875 for 350 pounds. Motion to authorize Neil Weaving to order 350 pounds of grass seed from Twin City Seed for a cost of \$875.00 (Breker/Bopp) Upon roll call vote, motion carried unanimously.

Motion to approve the Application for Drainage Work Within County Road Right-of-Way from Terry Wehlander, Milnor, to clean the ditch for Brian Anderson's drain tile water on the west side of Section 15-132-53 – Hall Township keeping the slopes the same as before the work started. If any engineering work is needed, the cost will be incurred by the applicant. (Arth/Anderson) Upon roll call vote, motion carried unanimously.

Motion to provide a letter of support to the ND Department of Commerce regarding Milnor City's request for the Rural Slum and Blight Removal Grant to remove a structure on their Main Street. (Arth/Anderson) Upon roll call vote, motion carried unanimously.

The commissioners proceeded to open the bids for surplus property that was advertised for sale. Motion to accept all high bids for those items; items not sold should be disposed of as soon as possible. (Arth/Anderson) Upon roll call vote, motion carried unanimously.

Approve April payroll in the sum of \$300,041.93 and the following bills. (Anderson/Breker) Upon roll call vote, motion carried unanimously.

The commissioners were made aware that the sales tax question could not be put to the vote of the people at the Primary Election in June. Per the Home Rule Charter, the question does have to go through the ordinance process first. Ms. Pfau will prepare the ordinance and start the process, so the question can be placed on the November General Election ballot.

Motion to rescind the mag chloride bills sent to Rutland and Whitestone Hill Township, as the townships did not approve the mag chloride application in these areas. (Arth/Anderson) Upon roll call vote, motion carried unanimously.

Motion to deny the Sargent County Water Resource Board's request for any culvert cost-sharing on the Drain #11 project upon the recommendation of the state's attorney, due to the fact that the project does not comply with the law, so therefore the county is not obligated to cost-share under the cost-share statute. (Bopp/Breker) Upon roll call vote, motion carried unanimously.

Tim Faber, Road Supervisor; Damon DeVillers, Interstate Engineering; and Jerry Beckmann, Bargen, Inc.; arrived at the meeting. Mr. Beckmann gave a very informative presentation on Gap Mastic to repair large, distressed cracking on county roads. He provided quotes for materials enough for County Road #7 and possibly part of County Road #10. He recommended doing the rest of County Road #10 next summer. Approximate cost of the project would be \$215,000. Mr. DeVillers also recommended applying a seal coat on County Road #14 from NDSH #11 south five miles at an approximate cost of \$411,000. The commission will make their decision at the May 7th meeting.

Commissioner Breker brought up issues with County Road #5 and is wondering about a long-term solution. Commissioner Anderson also requested Mr. Faber look at a couple of areas on County Road #7 and County Road #10.

There is a new road department employee. Michael Fettig has been hired at Grade22/Step1 and will be starting his CDL training.

Duane Peterson, Human Resources Director, provided the clarification needed for the March 19, 2024 tabled motion: 318 Bereavement Leave – Motion to adopt the changes recommended. The motion was made by Commissioner Anderson and seconded by Commissioner Breker on March 19. Upon roll call vote, motion carried unanimously.

Mr. Peterson also requested that Policy #404 – Paydays, be reviewed. He stated that it is vital to the recruiting and retention efforts of the county to change the paydays from monthly to semi-monthly or bi-weekly. More research and information will be needed before moving forward with this change.

Trent Mahler, Forman Ambulance, arrived at the meeting. He is requesting additional funds, as there were unexpected financial obligations to be met. Motion to expend \$22,600 to the Forman Ambulance out of the EMS funds. (Breker/Arth) Upon roll call vote, motion carried unanimously.

Mr. Mahler also provided a quarterly report for January through March 2024. The Forman squad had 34 runs in that time frame. He reported to 19 of those runs & Mr. Owen reported to 12 of them. He provided three CPR classes and stated that volunteers are always needed.

Cindy Yagow, Treasurer/Recorder/Clerk of Court, arrived at the meeting. Carpet will be installed through the Courthouse Facility Grant May 8 & 9, and she is looking for help moving furniture in & out of offices, the judge's chamber, the courtroom & the conference room. Mr. Peterson offered to help and the road department will be contacted to help as well.

Commissioner Breker, Mr. Peterson, and Ms. Pfau will meet with Brian Tayer to discuss further the assistant ambulance coordinator position for the Milnor Squad.

The airport authority contracts with Milnor & Gwinner Cities will be reviewed further at the May 21st meeting.
