Approve April 4, 2000 minutes. (Wyum/Wehlander, unanimous)

Connie Gulleson presented the 5 Plus 5 Challenge evaluation on the nutrition education classes. They were successful with 12 employees participating. Sonja Gulleson was the winner of one day of annual leave.

Dennis Dockter, Council member, City of Cogswell, asked about enforcement of ordinances in Cogswell. They plan to promote a citywide cleanup and would like assistance with enforcement. The Board suggested that they contact an attorney or proceed according to the bylaws of Cogswell City Ordinance 63, pertaining to public nuisances.

Approve Site Authorization to Bullis Post No. 84, Lidgerwood to conduct games of chance at the Geneseo Bar & Cafe from 7-1-00 through 6-30-01. (Smith/Wehlander, unanimous)

Sparky Engquist recommended Owen McGregor's probation is complete after 120 days and full-time equivalent be approved effective 4-9-00. Approve (Smith/Wyum, unanimous) Discussed request for a field crossing 3 miles south of Rutland on the Wild Rice River. The landowner should contact the Water Board for approval. Also discussed purchasing a different pickup, road project on Co. # 3, patching projects on roadways, purchasing tires, anchoring the storage building and prices for stockpiling gravel. County No. 1 in Dunbar Township will have clay and dirt removed from the ditches and placed around culverts on 10A to improve that roadway.

Wendy Jacobson, representing the department heads informed the Board the department heads would meet the last Thursday of each month in the conference room. Minutes will be distributed to the department head. She asked about receiving the commission minutes prior to approval and agendas. Commissioners will approve minutes before they are distributed. Authorize unused furniture and equipment be displayed and offered for sale to the public. The Board will review bids on May 16, 2000.

The SC District Board of Health recommended to the commissioners that the SC Courthouse be made a smoke free building. A copy of the Assurances for Federal Financial Assistance was attached to the recommendation. Tabled.
