The Board of Review and Equalization reconvened at 11:00 a.m. with Sandy Hanson, Tax Director and Shannon Jablonsky, Assistant present. Sandy presented the proposed changes for cities and townships from the local and county levels and the agricultural increase. Motion to approve the changes as presented with the exception of Parcel 12-4061000 (Wallace Johnson) in which Milnor Township Board of Equalization recommends a reduction in the property value from \$55,483 to \$51,292. Steve Wyum commented that there is an inundated land provision for water on land otherwise there are other water issues in the county. Bill Anderson commented that it appears that this property is already valued substantially lower than the surrounding properties and it appears that any loss in value due to wet conditions has already been taken into consideration. (Wyum/Orn, unanimous). provided the Board information on a proposed increase in agricultural land valuations for the 2010 tax year. In order to stay in compliance with the requirements of the State, she recommends an increase to 96.5% of full valuation, which is a 6.35% increase across the board on all agricultural land. Motion to approve. (Wyum/Waswick, unanimous) Norm Preble, former Tax Director, arrived at the meeting. Discussed residential and commercial values for the 2010 tax year, and the fact that no information was available from the State Tax Commissioner's Office at this time. Recess as a Board of Review and Equalization subject to call by the Chairman pending additional information from the ND State Tax Department. (Waswick/Anderson, unanimous)

Randy Pearson, Milnor and Bruce Speich, Milnor along with Sparky Engquist, road supervisor and Sandy Hanson met with the Board. Randy Pearson questioned the tile projects contributing to the water in Buffalo Lake and how long these tiles will allow water in the lake. Sparky stated that the road was built without a culvert and he believes that the installation of the culverts under County 10 will allow natural flow. Bruce Speich is very concerned about the apparent increase in water in the eastern part of the county, particularly in the Wild Rice River, and his perception that nothing is being done to protect property in that area. Mr. Speich would like to know what can be done to alleviate these water issues. He had several photos and aerial maps of the problem area, which includes a dike that he and a neighbor, James Berndt, had built a number of years ago. Among possible solutions discussed was the possibility of forming a legal drain and/or a drainage assessment area in the location of the affected property, in order to obtain adequate funding to contend with the water issues. Mr. Speich also presented a letter addressing his concerns about the road department supervisor and employees and perceived deficiencies in their job performance. The letter will be kept on file in the office of the County Auditor.

County Road Supervisor Sparky Engquist proceeded to discuss road repair, blading, culverts, graveling and pavement in the county.

Janeen Stenso, Red River Basin Commission, met with the Board to provide an update on activities including information on the Agricultural Water Enhancement Program, the Natural Resources Framework Plan, the Basin Wide Flood Flow Reduction Strategy and the 2011 annual conference in Fargo.

Sparky Engquist continued his report on road issues including updates on: the situations at Buffalo Lake, Kraft Lake and Alkali Lake; emergency repair projects; FEMA projects; and; dust control. The Board placed a conference call to inquire about a road surfacing product made from soybean, canola and corn oil. The Board may consider using this product on a demonstration project.

Mike Walstead informed the Board that Dwain Elenberger, Milnor City maintenance, notified him that the City of Milnor would be receiving grant monies for the two solar-powered stop signs located on Milnor City Main Street (County Road # 10). The City will not need cost-sharing from the Sargent County Road Department budget for this project.

Authorize Chairman and County Auditor to execute the revised Maintenance Agreement for County/Township Roadways within NDDOT Right of Way, upon receipt of the revised contract from NDDOT, and upon review by the Sargent County States Attorney. (Anderson/Wyum, unanimous)

Motion to appoint Terry Euscher, North Sargent School District (SC Combined District # 2) and reappoint Nancy Glarum, Sargent Central School District (SC Combined District #1) to the Sargent County School Reorganization Board for a three year term. (Anderson/Orn, unanimous)

Motion to reappoint Janet Kiefer, Cayuga, to the Sargent County Social Service Board for a three (3) year term starting July 1, 2010. (Orn/Wyum, unanimous).

The Board reviewed the results of the Official Canvass of the June 8, 2010 Primary Election. Approve certification as follows on county offices: County Commissioner Combined District No. 1 – Steven Wyum-681; County Commissioner Combined District No. 2 – Richard Ruch-251; David L Jacobson-531; Jerry Dill-160; Mike Walstead-681; County Auditor – Sherry Hosford-828; County State's Attorney – Trent W Mahler-388; Lyle R Bopp – 514; County Treasurer/Recorder/Clerk of Court – Gina Hillestad – 815; County Sheriff – Travis A Paeper – 824; Official Newspaper – The Sargent County Teller - 827 (Waswick/Anderson, unanimous)

Approve professional service agreement with Computer Professionals Unlimited, Inc., Morris, MN for a four (4) year term. (Orn/Waswick, unanimous)

Discussed the agreement between ArcaSearch (project for digitizing and processing of commission minutes) and Sargent County. Upon recommendation of the County Auditor motion to not renew said agreement (\$1236/year) for maintenance, updates and support, storage and delivery. (Anderson/Waswick, unanimous) Sargent County has received the DVD's with all the minutes from 1883-1940 that have been digitized and are located on the county website.

Approve County Township Road Mileage Certification to the State Treasurer certifying 800 miles. (Wyum/Orn unanimous)

Authorize Wendy Jacobson, Social Service Director, to hire a Social Worker 3 and In-Home Care Specialist 3 at Grade 13/3 and Grade 5/3 respectively. (Wyum/Anderson, unanimous)
