The Sargent County Board of Commissioners met at 9:05 with the following members present: Wade Anderson, Jason Arth, Lyle Bopp, Mark Breker, and Scott Johnson. Also present was Duane Peterson, Human Resources Director; Jayne Pfau, State's Attorney; Tia Bopp, Auditor's Office and Pam Maloney, County Auditor.

Chairman Scott Johnson called the meeting to order.

The Pledge of Allegiance was recited.

Motion to accept the agenda as amended. (Breker/Anderson) Motion carried.

Motion to approve the June 4, 2024 meeting minutes. (Anderson/Bopp) Motion carried.

The first reading of Sargent County Ordinance 2024-1: An Ordinance by Sargent County to Establish and Regulate a Sale, Use and Gross Receipts Tax was held. After publication, a second reading will be held at the July 2, 2024 commissioner meeting.

Brian Tayer, EMS Coordinator-Milnor Squad, arrived at the meeting. A recommendation was made by the Human Resources Director to offer the position of EMS Chief Coordinator to Trent Mahler at an annual salary of \$80,000. After much discussion, Mr. Peterson was asked to review the current job description for the position, make necessary changes and submit to DDA Human Resources for a review of the position grade. Upon receiving grade information, Mr. Peterson can propose to the commission a Grade/Step for the position.

Neil Weaving, Custodian, arrived at the meeting. Questions were raised about the removal of the custodian's sheds to prepare for the parking lot project. Mr. DeVillers had stated at a previous meeting that the contractor would remove the sheds. Mr. Weaving is in the process of removing items from the sheds & will be storing some items in Commissioner Bopp's shed off-site.

Motion to authorize the Chairman to sign the Notice of Award forms for the Bituminous Seal Coat & Patching Project – CP-4135(024) to Morris Seal Coat & Trucking; and for the Courthouse Parking Lot Reconstruction and Lighting Project – CP-CH001(024) to Gast Construction. (Anderson/Bopp) Upon roll call vote, motion carried unanimously.

Motion to appoint Kelsey Martinson to the Sargent County Health Board for a five year term – term ending April 19, 2029. (Breker/Anderson) Upon roll call vote, motion carried unanimously.

Motion to appoint Trent Nelson to the Sargent County Weed Board for an unexpired two year term – term ending August 10, 2026. (Anderson/Breker) Upon roll call vote, motion carried unanimously.

Motion to approve the filing of a building permit with Forman City for the parking lot reconstruction. (Breker/Arth) Upon roll call vote, motion carried unanimously.

The commissioners reviewed an email and invoice from Nadine Julson for accounting services for years ended 2018, 2019, 2020 & 2021 in regards to the Forman Ambulance Squad. Motion to pay the invoice to Nadine Julson, LLC. (Breker/Bopp) Upon further discussion, the board would like a more detailed billing and a findings report before cutting the check. Motion tabled.

Motion to approve and have Chairman sign 2024 Township Road Miles Certification -776 miles. (Breker/Anderson). Upon roll call vote, motion carried unanimously.

Motion to authorize the Chairman to sign a letter to NDDES giving approval for access to the NDACO portal for the collection and remittance of 911 fees. (Anderson/Bopp) Upon roll call vote, motion carried unanimously.

Travis Paeper, Sheriff, arrived at the meeting. He is requesting that Logan Peterson be moved up a step, as he has completed his probationary period. Motion to move Logan Peterson to Grade C43/Step3 effective July 1, 2024. (Arth/Bopp) Upon roll call vote, motion carried unanimously.

Sheriff Paeper also stated that he is considering a bulk gas barrel for his department to use, as Gwinner One Stop has sold to Casey's, and he would like to keep his business with locally owned businesses. Security and snow removal were concerns that the commission had, along with purchasing the barrel, rather than renting or borrowing from the business.

Sheriff Paeper reported that his department has had some Telehealth training due to mental health situations they have been involved in. He and the deputies have an iPad that can be used to access mental health providers when needed, instead of having to automatically transport to a facility. He has also received seven body cameras & six tasers from US Fish & Wildlife, as they have upgraded their equipment and the sheriff's department could have the old equipment at no cost. Sheriff Paeper also gave a brief summary to the commission on the Active Assailant Drill that courthouse employees were involved in on Monday, June 17<sup>th</sup>.

Tim Faber, Road Supervisor, arrived at the meeting. He stated that the crew has been graveling & blading.

Commissioner Arth left the meeting at this time.

Mr. Faber would like the county to purchase an enclosed trailer for road signs. Motion to purchase an 8½ x 30 foot enclosed trailer to use to store & travel to sites around the county for a purchase price of \$7000. (Breker/Bopp) Upon roll call vote: Yes – Bopp, Breker & Johnson. No – Anderson. Absent & not voting – Arth.

Approve June payroll in the sum of \$310,369.72 and the following bills. (Breker/Anderson) Upon roll call vote, motion carried unanimously.
