Sparky Engquist, Road Supt. met with the Board to review road projects. Bargen Inc. is filling cracks on the roadways on County # 12 north of Cayuga and #14 south of DeLamere. The Keystone Pipeline crew is hauling pipe in on ND Highway 11 and County #2. Discussed the overweight permits and fees collected. A motion made to deposit all overweight permit fees into the Road Fund. (Wyum/Anderson, unanimous) Discussion followed on use of magnesium chloride for dust suppression on the roadways. Several areas were suggested for this process including portions of the road to and around Silver Lake. The matter will be referred to the Park Board for discussion at the August 5 meeting. Base One surfacing projects are underway on County #1, with portions of County #14, #7, #3, and #2 to follow. Other areas were also suggested for consideration for applications of this product. The weed mowing rate was discussed and a motion to increase the weed mowing rate to \$135 per half-mile was made. Townships will be informed of this change. (Wyum/Waswick, unanimous)

Holly Jessen, SC Teller arrived at the meeting at 10:25 a.m.

Sandy Hanson, EMS/911 coordinator presented a Memorandum of Understanding (MOU) establishing a Mutual Aid Agreement between Richland, Cass and Sargent Counties to render supplemental emergency assistance in the event of flood, fire, earthquake, tornado, snowstorm, terrorism or other local emergency, natural or man-made, that has developed or appears to be about to develop to a magnitude beyond the capabilities of a single County, requiring additional forces to control. Several conditions were set forth in the terms of the MOU. Sandy would like to have one understanding signed off by all entities within the county/region. Tabled until Sandy Hanson presents an update. Also discussed a communication grant and upcoming courses being offered throughout the state. A burn ban was reviewed at a quarterly meeting earlier today and the group agreed that a policy should be prepared and adopted. Sandy had met with Richland County 911/Emergency Management to discuss a proposal for 911 – "Saving Seconds-Saving Lives. Sandy will continue discussing the 911 issues with Richland County, but no change from the current arrangement with State Radio is contemplated at this time.

The Board reviewed the insurance limits for buildings and contents listed on the Schedule of Property with the ND State Fire and Tornado Fund and found that coverage amounts appear to be adequate. Authorized County Auditor to sign premium notice statement.

Meeting recessed to Thursday, July 24 at 8:00 a.m.

The meeting reconvened at 8:00 a.m. on Thursday July 24, 2008 with the following present: Maurice Orn, Jerry Waswick, Steve Wyum, Bill Anderson and Mike Walstead. Absent none.

The Board proceeded to work on the 2009 budget.

At 11:30 a.m. Richard Cayko, ND County Commission Association President from McKenzie Co., Rodney Ness, ND Association of Cos. (NDACo) President from Burleigh Co., Mark Johnson, Executive Director, NDACo; Aaron Birst, Legal Counsel, NDACo and Jeff Eslinger, Director of Communications, NDACo arrived in Sargent County for a tour of the courthouse and a meeting with elected officials and appointed department heads. The purpose of the "President's Tour" is to increase communications among county officials, NDACo and NDCCA and to answer any questions the county has about services and programs the organizations provide. The 2 presidents and the NDACo Executive Director also discussed efforts that will be made by the 2 associations, in cooperation with the League of Cities, Township Officers, School Board Association and other public and private groups to reduce the need for property tax increases by encouraging the 2009 Legislature to appropriate some of the State's projected \$1.2 billion budget surplus to support local government entities and increase funding for roads.
