Approve August 2, 2005 minutes as corrected. (Waswick/Wyum, unanimous)

Lyle Bopp arrived at the meeting at 10:10 a.m.

Brian Tayer, Ambulance Coordinator, reported on the Milnor Squad statistics for 2005. Marwood Klein reported on the Forman Squad. Upcoming classes and total runs for both squads were reviewed. Discussed installing a black box in Forman for better reception on pager calls. Sandy Hanson indicated there is money in the 911 Fund for this equipment. The Board instructed her to proceed with ordering a black box for use by the ambulance service and other emergency services in Forman. (Anderson/Waswick, unanimous)

Gina Hillestad met with the Board to discuss initiating ACH for direct deposits to county government entities including cities, school districts, township, city parks and fire districts. First National Bank, Milnor has the capability of providing this service for a fee. The setup fee of \$50 will be waived but a \$20 per month fee will be charged plus \$5/batch and \$.06/transaction. Proceed with implementing the government entities with direct deposit with a target date of October 1. (Wyum/Anderson. Roll call: Aye: Anderson, Waswick, Wyum and Brockman. Nay: Walstead. Motion carried.) Also contemplate additional phases to include payroll and other vendors. According to the County Treasurer, the pledge of assets for Sargent County Bank at \$4,655,000 and \$825,000 at First National Bank, Milnor are adequate.

Lyle Bopp, Travis Paeper, Sherry Hosford and the county commissioners are all County Officials granted membership in the North Dakota Association of Cos. They met to elect a county representative to the State Council. Sherry Hosford nominated Jerry Waswick. Travis Paeper seconded the motion and moved that nominations cease and cast a unanimous ballot for Jerry Waswick. Motion carried. Mr. Waswick will serve a two-year term as the NDACo Delegate for Sargent County.

Travis Paeper presented a letter informing the Board that effective with today's date, Deputy Chris Sandvig's probation has ended and he will be eligible for any pay increases. The Board acknowledged his recommendation.

Sparky Engquist, road foreman met with the Board to present an update on the road department activities. Bridge 118-20 replacement project is complete and will be inspected for final acceptance. The road department will be doing chipping, road building on # 12, finish graveling and bridge repairs. The maintenance overlay project on # 4 and # 10 is re-scheduled to begin Sept. 15 and Sparky will replace the culverts on the # 10 site prior to the paving project. Sparky requested some part-time help for the fall chipping, culvert work and the Board approved hiring Dennis Goltz at \$9.25 per hour. Also discussed test projects with a non-corrosive product, conducting sign inventory and getting ready for the fair. The Weed Mowing Notice was reviewed and the price increased to \$100/one-half mile due to increase in fuel cost. Discussed previous holiday hours paid to road department employees. The Board feels that the employees have been adequately compensated for these hours and the States Attorney was instructed to draft a memo to that effect.

Ray Brockman and Bill Anderson, members of the SC Planning Commission relayed a message from the Planning Commission about possibly expanding the county zoning ordinance to include other areas. Currently, the county is zoned for solid waste and incineration facilities. All twenty-four townships are also zoned and take priority over the county plan. The Board indicated that the Planning Commission should prepare a list of areas that they would like to see zoned and present to this Board for their consideration. Lyle Bopp indicated that he may have a copy of a previous draft that the Planning Commission worked on a few years ago. He will make copies and return to this Board for their review.

A request was received for the 2:00 a.m. opening for bars located outside city limits. The county ordinance states a 1:00 a.m. closing. Amend county ordinance pertaining to the closing times of licensed bars and saloons located outside incorporated municipalities and under the jurisdiction of Sargent County to read 2:00 a.m. rather than 1:00 a.m. upon application by the bar and approval from the commission. (Anderson/Waswick, unanimous)

Authorize removal of computer #1772 from county inventory and approve for disposal. (Waswick/Brockman, unanimous)

Sherry Hosford presented levy information for the county fair. Upon review with the Board, no action was taken at this time.

Mike Walstead reported that the faulty paint job on the courthouse dome will be pressured washed and repainted. The contractor will present a letter to the commission guaranteeing his work.

Approve County Deed to Matthew and Heather Anderson, Cayuga for Lot 7 and the East Half (E1/2) of Lot 8, Block 2, Original Addition, City of Cayuga for \$1500. (Anderson/Brockman, unanimous)

Board members reviewed the 2006 budgets and designated September 6 as the date to hear from any department heads or organizations that have questions on their budgets.

Upon motion duly made by Commissioner Brockman and seconded by Commissioner Anderson the following resolution was adopted by a unanimous vote of the Sargent County Commission.
