Lyle Bopp, States Attorney arrived at 10:45 and requested that the Commission authorize the execution of an Admission of Service for a Quiet Title action concerning Lot 1, Block 1, Williamson's Addition, City of Havana. Authorize Chairman to sign the Admission of Service. (Jacobson/Walstead, unanimous)

Sandy Hanson, Tax Director/ Emergency Manager met with the Board and gave an update on the 2012 ND State Board of Equalization (SBOE) meeting regarding new values for residential property in Sargent County. A representative of Vanguard Appraisals, Inc. had also attended the SBOE meeting and informed the SBOE that the reappraisal resulted in a \$76,673,066 True and Full value for all residential classed property for 2012. This is an increase of \$21,027,922 or 37.8% above the 2011 True and Full value. Additional documentation was shared with the SBOE and a request that no adjustment of the sales ratio median of 94.7 be necessary for 2012. The SBOE will be in contact with Sargent County in late September with their decision.

Sandy discussed her 2013 budget and requested that the travel amount be reinstated from \$750 to \$1,000 as she has not attended training sessions due to other work and commitments and in 2013 she will be doing more travel and also to allow an additional \$4550 to the Automation and Telecommunication budget for 2013 for a Remote Edit License and service fees for the Vanguard Appraisals, Inc. Both amounts were approved.

Sandy Hanson discussed the results of her Job Description and also Shannon Jablonsky, her deputy and that she was very disappointed in the Grade that was determined. Currently she is a Grade 11/Step 9 and the previous Tax Director was 13/9 and the new classification for her combined job was listed as

Grade 12. She is asking to appeal the job description for both her and Shannon and will continue with her appeal. She is recommending that Shannon's job be classified as a Grade 7/Step 7.

Mike Walstead discussed the possibility of applying for an energy efficiency grant for new lighting in the courthouse. Courthouse Custodian Roz Amerman has reported that the 4 foot and 8 foot fluorescent bulbs & fixtures currently in use in the Courthouse are being discontinued, and she suggests that a plan for replacing the light fixtures now in use throughout the Courthouse be developed. Courthouse Commissioner Jerry Waswick will include as many of the rooms in the courthouse in the Court Facilities improvement grant application due in December 2012 for lighting replacement.

The Board recessed for lunch.

The Board reconvened after lunch.

Gina Hillestad, Treasurer/Recorder/Clerk of Court met to discuss her 2013 budget and requested that her department be increased to 40 hours per week as 35 hours is not enough time to get the work completed. She also indicated that Deputy Darlene Colbert plans to retire in August 2013, and the department will need to allow funds for training a replacement in the 2013 budget.

Steve Wyum made a motion to: calculate the cost of implementing a salary plan with step increases based on years of service, pursuant to the draft pay plan schedule he submitted; and, increase the Treasurer/Recorder/Clerk of Court and the Tax Director/Emergency Manager's office hours to 40 hours per week (8 hours per day, 5 days per week); and, use a Grade 14/Step 9 for Sandy Hanson and Grade 7/Step 7 for Shannon Jablonsky for 2013 budget computation purposes; and, to place all these adjustments into a contingency fund for 2013 budget planning purposes the, the contingency budget being sufficient for all phases of the motion to be implemented effective January 1, 2013. Jerry Waswick seconded the motion. Discussion followed on implementing this plan and changing courthouse hours for the offices concerned. Jerry Waswick left the meeting to keep an emergency dental appointment at this time. The Chairman called for a vote on the motion. The voice vote was apparently a tie, so a roll call vote was called for. Commissioner Waswick rejoined the meeting by telephone. Voting Aye: Waswick, Wyum and Anderson. Voting Nay: Jacobson and Walstead. Motion carried 3-2.

Damon DeVillers, Interstate Engineering; Sparky Engquist, Road Supt and Lyle Bopp, States Attorney arrived at the meeting at 1:50. Damon explained a letter requesting an extension for submission of funding requests for the 2010 ER projects in Sargent County. NDDOT is getting pressure from the Federal Highway Administration (FHA) to close out on these projects, but the paper work is not complete. Sparky stated that he is in the process of compiling the information and it will be submitted to NDDOT for reimbursement for the emergency work that has been completed. Motion to authorize the Chairman to sign the letter to NDDOT requesting an extension for the submission of reimbursement requests for the Repairs completed on three 2010 ER projects. (Walstead/Jacobson, unanimous) Also discussed the recent completion of the County Road #4 Micro-Surfacing project north of ND Highway #13, and other potential improvement projects, as well as possible sources of funding. The weed mowing notice will be placed in the paper to inform the landowners of the deadline for mowing road ditches. Also discussed faded road signs and possible sources of funding available for replacing signs.

Motion to authorize the Treasurer's Office to write off two uncashed checks that are more than 2 years old. The following checks will be written off - #62237 dated 4/16/10 to Janet Schroeder for \$250 and #28596 dated 11/2/09 to Tina Mohs for \$8.71. (Jacobson/Wyum, unanimous)
