The Sargent County Board of Commissioners met at 10:30 a.m., following the park board meeting, with the following members present: Mike Walstead, David L Jacobson, Bill Anderson, Sherry Hosford, and Jerry Waswick. Also present were County Auditor Pam Maloney, States Attorney Lyle Bopp and Jeanne Sexton-Brown, The Sargent County Teller.

Ken Forster, Sargent County Fair Board, arrived at the meeting and gave a brief report on repairs and improvements to the fairgrounds, and on the 2015 Sargent County Fair. There has been drain tile installed, a new electrical panel into the auditorium and the addition of the new horse barn. The Fair Board was very pleased with the attendance at this year's fair and has already booked entertainment for the 2016 fair. The commission thanked Mr. Forster for his report and commended the fair board for the improvements made to the grounds and for another successful fair. Motion to appoint Al Colemer as delegate to the State Fair Association's Annual meeting to be held in Minot on November 9, 2015 at 1:00 p.m. (Waswick/Anderson, unanimous)

Merrill Engquist, Sargent County Road Supervisor; and, Damon DeVillers, Interstate Engineering; arrived at the meeting. Damon reported that Mark Sand & Gravel has started on County Road #2 by Crete, as of Tuesday, September 8, & will move to County Road #14, once the preparation work on #2 is complete. Damon is anticipating a February/March bid letting on the HB1176 surge money projects which will be to finish County Road #14 to the South Dakota border and the rest of the funds will be available for use on County Road #12, or other projects, if sufficient funds are available. There is also some surge money remaining from HB1358 which can be used in these current and future surge bill projects. There is also additional Special Road Fund money that can be applied for through ND DOT for County Road #12. SRF projects are limited to roads that provide access to and/or are within recreational, tourist, and historical areas and County Road #12 is the route to the Tewaukon National Wildlife Refuge so it would be eligible. Damon will start the application process. He also reported that the Hall Township Bridge project is waiting for the Corps of Engineers to determine wetlands jurisdiction. The gravel being tested out of the stockpiles that have been, or are being, put up for the county have all been passing inspection, as of September 15.

Merrill Engquist provided a map & information on the progress that has been made by contractors on the County's graveling projects. Motion to extend the deadline on the contractors' graveling contracts to October 6, 2015, rather than the October 1 deadline written in their contracts. (Waswick/Anderson) Roll Call Vote: Waswick, Anderson & Walstead – YES. Jacobson & Hosford – NO. Motion carried.

The repairs to the highway shop roof have been completed and the bill received.

Motion to authorize the Treasurer's Office to write off three uncashed checks that are more than 2 years old. The following checks will be written off - #67086 dated 12/19/12 to NDAE4-HYW for \$80.00; #67332 dated 2/20/13 to Caleb Kluck for \$5.00; and #1436 dated 5/14/13 to Island Bar for \$25.00; all written on Sargent County Bank. (Anderson/Waswick, unanimous)

At 1:00 the Board proceeded to meet with department heads on the 2016 budget. Gina Hillestad and Alison Toepke, Treasurer/Clerk of Court/Recorder's Office, met with the board regarding digitizing the record books in the Recorder's Office to make them available for on-line document searches and retrieval. The approximate cost is \$55,000, but if the work is done towards the end of 2016, the fee could be paid in two installments – half from the 2016 budget and then in January of 2017 to come from the 2017 budget. The board requested that Ms. Hillestad and Ms. Toepke find out if it could be paid in three installments and bring that information back to the October 6<sup>th</sup> meeting. Ms. Hillestad also introduced Vanessa Bayger as the new staff member in her office. She again reiterated the need for a fourth staff member in the Treasurer/Clerk of Court/Recorder Office and wanted to know if the board had considered her request.

Sandra Hanson, Tax Director/911 Coordinator/Emergency Manager, met with the board regarding the staffing in her office. She has interviewed several applicants for deputy's position that has been vacant since August 21<sup>st</sup>. She is hoping to hire soon, but would like to know whether the board had considered her request for the deputy position to be a 35 hour/week position rather than 28 hours/week, as this will make a difference as to which applicant is offered the position. The board agreed that the deputy should also be certified in assessing. Motion to change the deputy position in the Tax Director/911/EMA office to a 35 hours/week position immediately upon hiring and that such position will be at a Grade 7/Step 1. (Hosford/Waswick) Roll Call Vote: Yes – Jacobson, Waswick, Anderson, Hosford and Walstead. No – None. Motion carried.

Motion to hire a fourth staff member for the Treasurer/Clerk of Court/Recorder office at 35 hours/week effective immediately. Hours for all employees in that department will be 35 hours/week effective October 1, 2015. (Waswick/Anderson) Roll Call Vote: Yes – Waswick, Anderson and Walstead. No – Jacobson & Hosford. Motion carried.

Travis Paeper, Sheriff, met with the board to discuss his request to move Brenda Peterson's, Chief Deputy, position to 40 hours/week instead of 35. The Community Service money he receives can be used for salary to offset the expense. He also asked them to reconsider giving a higher percent than the 1% COLA employees are tentatively receiving for raises in 2016, or to consider paying more of the employee's retirement percentage in lieu of a larger raise. He stated that there are many counties that pay the full percentage of their employees' retirement plan.

Commissioner Waswick stated that the PIP completed for the Social Services Director was mailed by certified mail to her that morning, as she is out of the office until September 21, 2015. She will be on paid administrative leave for 60 days to complete the PIP before coming back to work.

Motion to approve the 2016 preliminary budget in the amount of \$9,256,622. (Anderson/Hosford, unanimous) A public hearing will be conducted on Tuesday, October 6, 2015 at 6:00 p.m. in the commissioner's room, Sargent County Courthouse, Forman.
