Approve Sunday Permit for the sale of Alcoholic Beverages at Geneseo Bar, Geneseo, ND for twelve months. (Walstead/Wyum, unanimous)

Tom McKinnon, Veterans Service Office has notified Sherry Hosford, County Auditor that he plans to retire from his job as VSO for Sargent & Ransom Counties on December 31, 2012. Currently Mr. McKinnon is an employee of Ransom County, and Sargent County contributes one-fourth of the expense of the combined office. He is in the Sargent County office one day each week. Jerry Waswick spoke with Ransom County Commissioner Steve Dick, and he requested that a letter be sent to Ransom County if Sargent County is interested in continuing the current arrangement. Motion to contact Ransom County to continue the current arrangement concerning the Veterans' Service Office, and to proceed as soon as possible to hire a replacement, with any additional expenses incurred by Ransom County in training the new VSO to be shared, proportionally, by Sargent County. (Waswick/Walstead, unanimous)

A brief discussion on recovering the cost of record research and providing electronic data to the public followed, due to concerns raised by the Treasurer/Recorder/Clerk of Court and the County Tax Director. Lyle Bopp, States Attorney was called to come to the meeting to discuss what is allowed and what is required by the various State statutes that address the subject.

Sandy Hanson and Shannon Jablonsky from the office of the Tax Director/Emergency Manager/911 Coordinator met with the Board to discuss the county pay plan. Questions were asked regarding step advancement based on years of service. The Board explained the process of hiring someone and the authority for a department head to place that employee at a Step 2 without approval from this Board. Shannon inquired about Grade/Step retroactive to anniversary date. No request has been made to make the pay increase retroactive to June 1, but Sandy Hanson did ask at the meeting that Shannon's pay be retroactive to June 1. The Board will consider the request.

Sandy Hanson addressed the communication problems experienced by local Fire Departments while responding to fire calls over the preceding weekend. The state is testing narrow banding systems but Sargent County has not been spot checked at this time. She has made a request for the spot check. It appears that part of the problem may be lack of familiarity with the operation of the new, narrow band digital radios, which Sandy plans to review with the groups utilizing the new radios. Sandy also discussed the possibility of adopting a burn ban for the county, or passing a Fire Danger Proclamation. No units of local or State government have cited the need for a burning ban, or requested either a burning ban or a fire danger proclamation, so no action was taken on either issue.

The Board recessed for lunch.

The Board reconvened after lunch at 1:00 p.m.

Lyle Bopp, States Attorney, arrived at the meeting to discuss the State statutes concerning charging for record research and providing electronic data to the public. Lyle provided a handout on Open Meetings and Open Record Laws. Following discussion the Board requested that Lyle prepare a draft resolution for the Board to consider at the next meeting to establish a statutory fee for research of records and electronic copies.

Brian Tayer, Milnor Ambulance Coordinator delivered to the Board specifications for furnishing one new Type I 450 ambulance with a 4x4 air ride, and requested to call for bids. The call for bids shall include an optional bid to take in trade, as part payment, a 1998 E-350 Ford Type III Ambulance. (Mileage-87,760). Instruct County Auditor to call for bids for one new ambulance for the Milnor Squad. Bids shall be opened October 16, 2012 at 1:00 p.m. (Walstead/Wyum. Roll Call: Aye: All. Nay: None. Absent and not voting: David L Jacobson. Motion carried.)

Lisa Dawson and Melissa Blawat, Extension Office met with the Board to inform them that their office staff, Candy Hansen may be out of the office for 8-12 weeks to care for her father. Ms. Hansen has adequate sick leave to use in her absence. But at this time it appears that other arrangements have been

made with other family members and Candy will be available in the office more than originally thought. October is hectic in the Extension Office and both Melissa and Lisa will keep all communication doors open for the public to get in touch with them.

Sparky Engquist, SC Road Supervisor met with the Board to update on road projects including: pending gravel projects; bridge repairs; repair of asphalt paving on County #12 through Cayuga, and on County #14 through Geneseo; magnesium chloride dust control applications; and, other road projects. Bill Anderson asked Sparky about the proposed use for the large culvert at Silver Lake, and about the possibility of acquiring 2 used multi-plate culverts for use in County repair projects. Sparky indicated that the culvert at Silver Lake may be used at a bridge site in Tewaukon Township; and, one of the multi-plate culverts could be used at a bridge location in Herman Township.

Nell Walstead, Secretary, American Legion Auxiliary Unit 82 of Forman met with the Board to request support for "Red Shirt Fridays" to indicate Support of Our Troops. Motion to support Red Shirt Fridays and draft a resolution to that affect. (Wyum/Waswick. Roll call: Aye: All. Nay: None. Absent and not voting: David L Jacobson. Motion carried.)

Approve a Beer and Liquor license for 2012 to: Coteau des Prairies Lodge, LLC, 9953 141<sup>st</sup> Ave SE, Havana, ND 58043 (Joe Breker and Olivia Stenvold, applicants). Motion to approve the application contingent upon receipt of approval from Tewaukon Township. (Waswick/Walstead. Roll call: Aye: All. Nay: None. Absent and not voting: David L Jacobson. Motion carried.)

Discussed a Traffic Safety Contract #12121758 awarded by the North Dakota Department of Transportation to the Sargent County Sheriff's Dept. The contract would provide funding from ND-DOT to the Sheriff's Department for additional hours worked enforcing DUI and seatbelt laws. Tabled until reviewed by the States Attorney.

The Board proceeded to work on the 2013 budget. Approve the 2013 Preliminary Budget in the amount of \$6,985,873. (Walstead/Wyum. Roll call. Aye: All. Nay: None. Absent and not voting: David L Jacobson. Motion carried.) A public hearing will be conducted on Tuesday, October 2, 2012 at 6:00 p.m. in the commissioner's room, Sargent County Courthouse, Forman.

The meeting adjourned at 4:05 p.m. (Waswick/Walstead, unanimous)
