The Sargent County Board of Commissioners met at 9:00 a.m. with the following members present: Bill Anderson, Steve Wyum, Mike Walstead, Maurice Orn and Jerry Waswick. Absent none.

Approve September 5, 2006 minutes as corrected. (Anderson/Walstead, unanimous)

Julie Hassebroek, Extension Agent, met with the Board to explain the ND Horizons Leadership Project, which strengthens the heart of small communities. It will spotlight leadership and poverty-reduction strategies for rural communities under 5,000 in size. The communities of Rutland and Forman have been identified as qualifying communities. A showcase is scheduled in Wahpeton on October 19. She encouraged participation from the commissioner's and other community members. Julie also discussed her preliminary budget for 2007 and questioned some of the line items.

Gina Hillestad, Treas., met with the Board to discuss the 2007 budget line item for deputy treasurer salary. She asked that the salary be allocated 100% to the Treas. budget instead of 80%-Treas. and 20%-Recorder's budget. She indicated that she would work with the Recorder to allocate time from the Treasurer's Office to the Clerk of Court's Office. Approved. Gina also reported on Personnel Board issues including an incentive policy for ambulance volunteers with a recommendation that a volunteer must be an "active" participant, the Dept. Head must approve the schedule and volunteers should receive credit for volunteering whether they are on day or night shifts. The Personnel Board also discussed personal days/hours and recommends that "days" should be hours based on the employees work week – 16 hours for employees working 40 hours per week and 14 hours for employees working 35 hours per week. A definition should be added to the SC Non-Social Service Personnel Policy defining a "day" as 8 hours for an employee working 40 hours per week and 7 hours for an employee working 35 hours per week. These Personal hours can be taken in 15 minute increments. Gina and Steve Wyum will meet with Lyle Bopp, States Attorney to review these changes and provide recommendations to the commissioners.

A conference call was placed to Dorothy Person, Government Management Group (GMG) to discuss a proposal for services to conduct a comprehensive market survey and comparison of salaries of comparable counties of selected benchmark positions for Sargent County. The proposal included a market survey, pay plan preparation and report and recommendation preparation, charts and handouts for a total cost of \$5650. After a lengthy discussion on the proposal a decision was tabled until receipt of additional background information.

The Board recessed at 12:10 for lunch.

The Board reconvened at 1:00 p.m. with Steve Wyum absent.

Joan Lee, Recorder, met with the Board to discuss the non-judicial duties and which office should have responsibilities for them. She feels some of the duties should be transferred from the Clerk of Courts Office to the Recorder's Office including marriage licenses, passports and military discharges and keeping those fees within the county. These two offices have been combined for many years in Sargent County. The Board felt that it is the Recorder's decision and encouraged her to transfer these duties to that office including the fees. Joan also requested information on the 2007 budget and salary allocation. The Board informed her that the salary line items in the budget-her salary and the deputy recorder salary-would be the only salary items in the Recorder budget for 2007 and the treasurer's office would work with her in staffing the Clerk of Courts Office. Sherry Hosford, Auditor indicated that her department would not have manpower to allocate to the Recorder's office in 2007.

June Fritzen, SC Historical Society, met to inform the Board that Sargent County will celebrate 125 years in 2008 and asked if the Board has thought of any plans for a celebration. The Board would like to work with the county fair board, county historical society and county officials to make plans for this event.

Sparky Engquist, Road Supt. met with the Board to discuss road dept. issues and update the Board on proposed projects. Reviewed the road and bridge replacement projects. Approve 2007-2008 Federal Aid Program and bridge replacement program and authorize chairman to execute the same on behalf of the commission. (Anderson/Orn, unanimous)

Approve agreement between Gwinner Farmers Elevator Corporation and Sargent County to store corn at the fair grounds from October 1, 2006 through March 1, 2007. (Walstead/Orn, unanimous)

Approve twelve month Sunday Alcoholic Beverage Permit to Geneseo Bar & Grill, Geneseo. (Orn/Anderson, unanimous)

Approve the following county funds as interest bearing accounts effective October 1, 2006: General fund, Road fund, Federal Aid Road fund, Job Development fund, Weed Board fund, Water Resource fund, and Capital Improvement fund. (Anderson/Walstead, unanimous)

Discussed second floor judge chambers and possibility of making improvements to that office through the Court Facilities Improvement grant funds. Appointed Mike Walstead, county commissioner Lyle Bopp, States Attorney, Joan Lee, Recorder and Judge Richard W. Grosz to a committee to prepare a list and description of improvements and maintenance items that are eligible for grant funding.
