Elaine Anderson, Deputy Auditor, explained the option available to the county to adopt an extension of time for Discovery Benefit FLEX participants. The Personnel Board will discuss it at their meeting, and make a recommendation.

Approve Juvenile Accountability Block Grant Program Certification of Award as requested by Sheriff Paeper. (Waswick/Anderson, carried).

Approve 50-50 cost share with City of Milnor on dust control on the south and north ends of Main Street (County Road #10). (Anderson/Brockman, unanimous).

Approve request from Gwinner Elevator to store corn in pile at fairgrounds under same rules as last agreement, and with removal date of March 15, 2006. (Waswick/Wyum, unanimous). Lyle will draw up agreement to be signed.

Gina Hillestad presented a summary of other counties' ACH usage and monthly fees.

Approve increasing the Job Development levy from the .27 mill levied in 2005 to 1.27 mills in 2006. (Wyum/Anderson. Roll call: Waswick, Brockman, Anderson, Wyum, Walstead, all ayes. Motion carried.)

Sparky Engquist, Road Foreman, was available by phone to discuss projects and answer questions concerning his department including bridges, request from City of Havana, personnel policy clarification, etcetera.
