The Board of County Commissioners convened in special session pursuant to the following call, viz,


Notice is hereby given, that a special session of the board of county commissioners of Sargent County, North Dakota, will be held at the Auditor's office in the town of Forman, on Monday the 28th day of May A.D. 1894 at 10 o'clock A.M. for the purpose of acting on a certain petition, praying for the organization of Tewankon Civil township, comprising township 129, range 54, and adjoining fractions, also for the purpose of organizing township 129 range 53 and adjoining fractions into a school district.

In order that the residents of the above mentioned territory may have the right and privilege of voting at the election to be held on the 19th day of June A.D. 1894, it is necessary that the Board should convene prior to its regular session to consider the matter of said petition.
