OLD BUSINESS

Riverside Housing Project-Nathan Berseth & Terry

Terry Dusek has showed the house in Milnor to an interested party. The house is completed except for a good cleaning to get ready for showing. Luke reported that Forman House needs garage sheetrock and flooring yet. Jessica stated that house in Gwinner still needs siding and some interior work completed. At this Time Riverside is still financing the houses and has done started a big sale campaign for the three houses. Suggested that Posters get up at Bobcat and the group asked if Scott could take care of that. Mortgage rates have seen an increase, hopefully will slow down. Nathan & Terry have been communicating with Joel at Riverside often.

Duplex Grant-Luke reached out to the FCDC and they show an interest and would like a meeting to understand more about how the grant will work and the responsibility of the FCDC portion. Luke will arrange that meeting between himself, Sandy Hanson, Nathan Berseth, Bryce Carlson and FCDC. At this time the \$185,000.00 grant has to stay with the SC JDA. Nathan Proposes that the duplex become a townhouse and if interested the FCDC will finance ½ the build owning one of the Duplex/Townhouse. The FCDC Then can begin advertising that ½ for sale right away. The estimated cost would be around \$\$300,000.00 to \$340,000.00. the SC JDA would then own the other ½ utilizing the \$185,000.00 on their half of the build which would be around the \$300,000.00.

\$340,000.00 amount as well. The grant states that the structure that is connected to the grant dollars needs to be retained by the SC JDA for two (2) years. After that time it can become for sale. If FCDC would choose to buy it or agree to buy it at that time they could purchase that 1/2 for the dollars of cost minus the \$185,000.00. The FCDC then can market that 1/2 for sale.

NEW BUSINESS

Dakota Dirt Coffee-Equipment Loan Presentation by Landon Mund & Beau Goolsbey

Would like to purchase a 2nd roaster for the coffee beans. The company has seen considerable growth over the last 2 years. They have hired 1 person and the 3 owners still commit to doing the work themselves over and above their other jobs that they have. They also hired a 2nd person for the holiday season. Currently they are roasting every day and can do 15 - 20 batches per day. Dakota Dirt is hoping to double that in 2023. Dakota Dirt has expanded into retail currently with Fargo Scheels since the start of the business; Tractor Supply (10 stores); Dakota Dirt can also be found in boutiques; as well as shipped out 60 bags to all Scheels stores to see how they sell as a trial for interest. They have a subscription network which people subscribe to and coffee is automatically sent out on a schedule. 2022 was a good year for that piece of sales. Dakota Dirt is currently expanding to k-pods and still intend to have a drive through business at their current location. Dakota Dirt is working with First Community Credit Union and the Bank of North Dakota for an interest buydown flex loan for the new roaster. The Loan will be a 5 year loan. Estimated buydown interest would be around \$1,200.00. Bryce/Robert move to have SC JDA participation for the interest buydown. The interest will be paid to BND annually upon invoice from BND. The payback to the SCJDA will begin 6 months after the principal loan has been paid off completely with the determination of % of interest and payment schedule at that time.
