#### **OLD BUSINESS**

Bio Mass Tour-Bill Anderson reported on a tour that he and several other county representatives took in Grand Forks and at NDSU. Bill reported that the tour and information was very good and continued progress on the switchgrass conversion to Bio Mass looks very promising in the future. It would be of great benefit for Sargent County to continue to monitor and support this progress, and establish Sargent County as a viable option for test sites and production of switchgrass.

### **NEW BUSINESS**

Four Seasons Nursing Home-Steve & Nathan updated the JDA on the nursing home. Currently has a \$30,000 payroll every 2 weeks. 79-80% of income is payroll. This payroll supports our tax structure and mainstreet businesses in the county. The Home trys to do a lot of its business with local businesses. Wage scale is competitive. Has 40 beds, 5 basics and 35 skilled. 39 beds are full. Needs to operate at 90% capacity. Jerome/Bill to renew the balance of \$79,243.76 for 5 years at the current interest rate with a balloon payment at the end. Motion Carried unanimously. Steve & Nathan will get loan payment schedule and agreement completed.

Nursing Home Interest-Jerry/Jerome to request from the commission that the interest from the loan be placed in the JDA for future projects. Motion Carried. Jerry & Ron will meet with commission.
