Loan Reports: Sandy reported that payments on loans are current.

OLD BUSINESS

<u>Lariat Bar</u> – Loan is completed with Gap Loan paid to Sargent County Bank. Payment schedule starts monthly payments beginning on October 1, 2017 with 4.75% interest and Amortization period is 20 years. <u>Spec House</u> – Interest on the Loan from Lake Agassiz is due May 14th. Lacy Wyum is the realtor handling the sale. At this time there is no flooring in the spec house, thought that new owners would like to pick it out themselves. Lacy suggested placing the flooring to give it a more completed look. Home is completed and Terry and Sandy await the remaining final bills. Terry and Nathan Berseth will continue to show the home. With no further old Business Sandy called for New business.

NEW BUSINESS

Southside Auto- Neil & Sara Planteen presented information to the Board regarding a purchase of the land and building that they are currently leasing from FCDC with an expansion of the existing building. Potential with expansion would be the ability to add to more stalls and two more mechanics to the employee list. Current employee base is Neil and Sara, 1 in the store, and 2 mechanics in the service and repair. Have been in business since 2014 and have added to the store inventory for sales as well as mechanic services available. They are

working with FSBND as well as BND and requesting that the SCJDA assist with an interest buydown program through BND. Neil & Sara are requesting from the JDA the interest by-down through the BND Flex-Pace program which would be approximately \$45,520.00 or \$3,050.00 annually. Mike/Randy to participate in the BND Flex-Pace program as the gap financing of up to \$46,000.00 for the Loan to include monthly payments with a 15 year payback at 1% over prime as of today pending completion of loan approval by the BND and FSBND. Sandy called for a role call vote: Bill-yes, Ron-yes, Jessica-yes, Mike-yes, Randy-yes, Carol-yes, Sandy-yes. Motion passed unanimously. Neil and Sara Left the meeting at 7:30 pm.

Chiropractic Business-Nathan Berseth introduced Cameron Schroeder, D.C. whom is planning to open a chiropractic business in Milnor. She will be leasing space inside the Emeric Erickson Bldg. The loan will be for \$20,000.00, a portion of the full Loan. She is working with a Bank from Wahpeton. Cameron is purchasing an existing chiropractic business in Lisbon as well and intends to use Milnor as a satellite location. This loan will be for equipment and startup costs. This loan may appear as a riskier loan as there is no ownership in the building. Will not start with staff, but hoping to hire clerical in the future as the business grows. Randy/Bill to borrow \$20,000.00 with 1% over prime for a 10 year amortization period and a 6 month grace period before payments start and security will be the equipment,

contingent on the approval from the BND and Wahpeton Bank that she is working with. Sandy calls for a role call vote: Ron-yes, Mike-yes, Jessica-no, Randy-yes, Carol-yes, Sandy-yes, Bill- yes. Motion carries with 6 yeas and 1 nay.

Sandy states that currently prime rate is at 4.0% for the record for both Loan recipients approved today. CCA Report-Nathan gives an update on the Spec home and his continued work with communities in Sargent County as they show interest in projects. He continues to seek potential names from all board members of various people in the county whom may be interested in investment opportunities within their communities or the county. If we can give him names with a contact number Nathan will do the rest. The CCA contract will be coming due in July for renewal. Discussion on future opportunities for housing in the county.

Round Table:

Ron reported that the museum will be opening memorial day weekend and the General Store is having an auction in early august to sell the contents of the building.

Mike reported that the Relay for life is holding its event June 23rd at the Courthouse yard in Forman.

Terry reported that Milnor City has purchased and placed their sign for the new development.

With no further business the meeting was adjourned.

Carol and Nathan both updated the group on the Hankinson event on April 18th that was geared towards economic development. They stated it was very worthwhile.
