Motion to advertise the 11.4 acres of hay land located on the north edge of Silver Lake Park to be hayed for 2023, 2024 and 2025 with bid opening on June 20th, 2023. (Anderson/Johnson) Upon roll call vote, motion carried unanimously.

Ms. Denault & Ms. Seelye reported that one of the seasonal park employees has been let go, as he wasn't working out. They will be hiring a young man to take his place, however, the new employee will be limited in duties, as he is only fifteen (15) years old.
