UNFINISHED BUSINESS: Manikowski will seal off the well before Memorial Day weekend. Calvin Jacobson is working at the lake today to dig the channel and level the sand. The new boat dock has been delivered to Buffalo Lake. The old dock will be kept for use at Silver Lake possibly in the new channel.

Garrison Diversion Conservancy District awarded the Sargent County Park Board \$5,000 for the expansion of the north beach and installing metered and unmetered pedestals. Proceed with installing 5 unmetered pedestals on the west side point using existing pedestals. (Anderson/Hoistad, unanimous)

## NEW BUSINESS:

Discussed the pickup/deer accident and the insurance coverage. North Dakota Insurance Reserve Fund has offered a salvage value of \$1100 less deductible of \$250 or we can keep it and receive a check from NDIRF for \$750 (\$1000-\$250 deductible). Motion to keep the 1990 pickup and look at replacing it, selling the pickup outright and Dennis will look at options and present at the June meeting. (Waswick/Anderson, unanimous)

Donations for the pavilion were received from Dyste's Store and in memory of John and Dorothy Dyste a total of \$200.

Looked at a recap on the pavilion and discussed options for proceeding with the project. Bill Anderson agreed to visit with The Sargent County Teller about placing an article in the paper promoting Silver Lake Park, the pavilion project and seeking donations.

Dennis Goltz suggested again that there should be gravel pads in the camping area with 2 trailers per pedestal. He was given the authority to get these pads in place by July 4<sup>th</sup>.

Cameron Enderson, Assistant Park Manager will not be available to work Memorial Day weekend and the first two weeks in June. Approve \$9.00 per hour for anyone who works in the absence of Cameron. (Waswick/Walstead, unanimous)
