The Sargent County Park Board met at Silver Lake Park at 6:00 p.m. with the following present: Quentin Hoistad, Steve Wyum, Jerry Waswick, Bill Anderson and Ray Nelson. Absent Maurice Orn and Mike Walstead. Also present Dennis Goltz, Park Manager. Other family members were present for the annual Park Board picnic.

Approve minutes of May 6, 2008 meeting as distributed and financial report with a balance of \$42,579.22 as of May 31, 2008. (Nelson/Anderson, unanimous)

UNFINISHED BUSINESS: Site # 6 in the Seasonal camping area is still vacant. Board members suggested posting a sign in the park kiosk and a notice in the Wahpeton paper of this vacancy. Discussed the south west beach project and Sparky Engquist, SC road supt., indicated he will donate his time if the county will provide the equipment. This would include two dump trucks and the track hoe. Crandall Construction will also rebid their estimate for sand when a more accurate amount is known. Approve use of county equipment and delay work until September 2008. All repairs are complete for the vandalism at the park in April. Community Service workers did much of the work. Wade Anderson received the bid for mowing the hay land. Mr. Anderson paid \$290. The pavilion project was discussed and Board members viewed various locations. An area straight north of the existing swimming beach appears to be a location to consider. Board members would like to view the pavilion at Dead Colt Creek to measure that pavilion and decide what size building to bid. This visit will be held in conjunction with the July meeting.

NEW BUSINESS: Ray Nelson reported that he had complaints of dog waste at the park. Several unhappy campers complained of dogs running and owners not cleaning up after them. Bill Anderson agreed to talk to States Attorney Lyle Bopp to draw up an ordinance about dogs at the park. Motion to purchase four signs to be placed around the park that read "Dog Waste is a threat to the health of our children-degrades our park and transmits disease" "Leash required and clean up after your dog. "It's required by Law". (Nelson/Anderson, unanimous) Tewaukon Rod and Gun Club sent a \$50 donation to the park. Discussed pumping septic tanks and Ray Nelson will talk to a company from Lisbon and ask them to come to Silver Lake. Dennis Goltz reported the pressure pump engine burned out and he found one from Northern Tool for \$399.99. This would include a new pump, engine and hoses. Approve purchase of the pressure pump. (Nelson/Wyum, unanimous)
