The Sargent County Park Board met at 9:00 a.m. with the following present: Mike Walstead, Ray Nelson, Bill Anderson Jerry Waswick, James Peterson and Steve Wyum. Absent: David L Jacobson Also present: Dennis Goltz, Park Manager and Paige Cary, The Sargent County Teller.

Approve May 21, 2013 minutes as read. (Peterson/Waswick, unanimous) Financial report showed a May 31, 2013, balance of \$56,444.36 in the county park and the pavilion fund with a balance of \$112.89 plus \$6,600 owed on the bank note. Approve financial report. (Walstead/Anderson, unanimous)

Motion that all rental fees received from the Pavilion be deposited into the Pavilion Fund. (Waswick/Wyum, unanimous)

Ray Nelson reported on a problem with getting keys when individuals are renting the Pavilion. Ray Nelson and Jim Peterson both have a set of keys in case the renter does not pick up the keys at the Auditor's Office. The Auditor's Office has two sets of keys and the renter is instructed to pick up the keys a few days prior to the dates of their agreement from the Auditor's Office. The renters are instructed to lock the doors and leave the keys in the Pavilion and Dennis Goltz will return the keys each Monday to the Auditor's Office.

Ray Nelson also reported that the refrigerator in the Pavilion quit working and cannot be repaired. Motion to authorize the Chairman to purchase a new or used fridge for the Pavilion. (Wyum/Waswick, unanimous) Ray will consult with other Board members prior to purchasing.

Rob Bundy, Refuge Manager, Tewaukon National Wildlife Refuge has submitted a proposed agreement to the Denver Office regarding the exchange of Service held wetland, grassland, and FmHA easements.

The water leak in the maintenance room of the Pavilion will be checked out this week by Dave Martinsen according to Dennis Goltz.

Maurice Orn, Stirum, former Commissioner and Park Board member stopped by the meeting to greet the Board members.

The Board proceeded to open bids for the 16 foot by 24 foot beach shelter. One bid was received from Martinsen's Home Center for materials, concrete and labor of \$5,799. Motion to accept bid from Martinsen's on the condition that the project be completed prior to September 15, 2013 and authorize the Chairman and Auditor to execute any agreements. (Anderson/Wyum, unanimous)

Ray Nelson informed the Board that Dennis Goltz had been contacted by a Dakota Hunting and Fishing Campground Guide Company last fall to place an ad in this publication at a cost of \$295, of which Dennis paid and Dennis is asking to be reimbursed for this amount. Approve reimbursement. (Wyum/Walstead, unanimous)
