Approve June 4, 2002 minutes as read and financial statement with a balance of \$9,008.48. (Nelson/Anderson, unanimous)

OLD BUSINESS: The T-shirts and caps have been received and Jerry is wearing. Ray Brockman reported that Sparky Engquist would dig a hole and prepare the culvert for the bathroom at Buffalo Lake. Signs were installed by the boat ramp and it has helped with the parking problem. Darwin Fliehs, Trent Nelson and Con Colby donated two loads of beach Discussed the vandalism, which occurred earlier this summer. All signs have not been repaired and the Board authorized the Secretary to order two directional signs @ \$250 each and two USDA signs @ \$335 each plus shipping and installing and \$60 for paint and \$100 for labor for a total of \$2500 damage. A letter will be sent to the States Attorney with these totals. (Nelson/Brockman, unanimous) Approve purchase of Plexiglas to place on the wooden (Anderson/Brockman, unanimous) Some of the trees are planted and some fabric will be installed tomorrow. Quentin reported that Orville Nelson will haul some gravel to the park and he and Orville will donate it. Discussed the boat dock at Buffalo Lake. Jerry hauled it back to Silver Lake because it was damaged. Jerry was instructed to take another dock out to Buffalo Lake immediately. Tom Orth is still working on repairs to the other 2 docks. GDCD notified Ray Brockman that no funds would be allocated this year to the project request from Sargent County. This was for the new bathroom on the southwest side, more electrical hookups and fireplace grills. The Board was encouraged to place another request next year.

NEW BUSINESS: The 2003 budget was reviewed. Approve \$26,750. (Smith/Nelson, unanimous) The bathhouses at the park are in bad condition. The Board inspected them and agreed they should be removed. Approve removal. (Wyum/Nelson, unanimous)
