UNFINISHED BUSINESS: The eight new seasonal sites are completed and rented. Four of the renters will be at the park for the remainder of 2010 and have paid \$5 per day for 2010. Dennis reported that the two south sites need more dirt and he will donate the dirt if he can use a county truck. Board members agreed that Dennis can use the truck and haul the dirt. The three swimming buoys arrived and are installed. Bill Anderson prepared a letter to present as an article to the Sargent County Teller regarding the pavilion and fund raising. Board members agreed that a picture should accompany the article and Dennis will talk to Dakota Valley Electric Co-op to see if the same letter can be placed in their magazine. Also suggested that the article be placed in the Ransom County Gazette. No decision made on what type of picture or who will take the picture.

Directed the Secretary to send out a notice of the rate increase from \$800/year to \$900/year for seasonal sites when the electricity bill is sent out this fall.

NEW BUSINESS: Harlan Klefstad, Forman donated \$5,000 and Bison Booster Club of Milnor donated \$250 for the pavilion.

Dennis informed the Board that B & K Electric had upgraded the pedestals on the north side camping area by the pine trees.

Sally Johnson, Milnor has been hired to work at the park until after Labor Day.
