MINUTES OF THE MEETING OF THE SARGENT COUNTY WATER RESOURCE BOARD HELD ON THURSDAY, JANUARY 17, 2019, AT 8:00 A.M. IN THE COMMISSIONERS ROOM AT THE SARGENT COUNTY COURTHOUSE, FORMAN, NORTH DAKOTA.

Managers present: Lucas Siemieniewski, Michael Wyum, Roger Zetocha and Bruce Speich. Absent: Todd Stein. Also present: Chris Gross, Engineer for the Board via conference call. The following residents and landowners were present: Paul Mathews and Robert Banderet.

**KEVIN THROENER – TILE PROJECT UNDER 80 ACRES; RAILROAD CULVERT WEST OF COGSWELL ON DRAIN NO. 11 AND CULVERT/GATE BETWEEN SECTIONS 27 AND 28 OF HARLEM TOWNSHIP:** Mr. Throener shared a foot print of a tile project located in the SE1/4-35-131-57 that he is proposing that entails 76 acres of drainage tile with an additional 4 acres of solid pipe. The map indicates the pipe is solid in the wetland areas and there would be a lift station in the far southeast corner of said project. If a tiling project is under 80 acres, this board has no jurisdiction over said project, however, Chris Gross encouraged Mr. Throener to file the paperwork for a permit, which would contact downstream landowners for one mile of this project and eliminate any question in the future. Mr. Throener commented that the water naturally drains into the Dr#11 pipe which comes from Cogswell City and flows southerly. Chris also reminded Mr. Throener that even if the project doesn't require a drainage permit, it is the landowners' responsibility to stay in compliance with USDA regulations.

Kevin Throener asked for an update on the railroad culvert west of Cogswell on Dr#11. The Board and Chris informed Kevin that there has been a turnover of staff at DMVW and the request from this board for culvert replacement has been pushed down the priority chain. Kevin requested contact information for the DMVW and the name and phone number of the contact person was shared with him.

Kevin Throener asked permission to install a culvert with a flap gate between Sections 27 and 28 in Harlem Township which would flow into Dr#11, as currently a berm is holding back the water. Board members informed Kevin that it is the responsibility of this board to install such culverts and agreed to work with Kevin when conditions allow for said culvert to be installed. Kevin will contact the board when the culvert can be installed.

Manager Zetocha moved to approve the Board's December 20, 2018 minutes and December financial report. Manager Speich seconded the motion. Upon roll call vote, the motion carried unanimously.

Manager Wyum moved to approve renewal of CD Nos. 13893 and 15075 for an additional twelve months at 1.75% interest. Manager Speich seconded the motion. Upon roll call vote, the motion carried unanimously
