UNFINISHED BUSINESS: The Board received a letter from the State Engineer regarding Emergency Drain Permit #3523 requested by the Sargent County Commission. A six month extension has been approved and the date to close the drain located in the SW1/4-17-131-54 (Shuman Township) unless a request for an extension is made 30 days in advance by Sargent County is April 12, 2011.

NEW BUSINESS: Central Power Electric Cooperative, Inc., filed a request for a utility permit proposing placement of a single wood pole overhead 43.8kV transmission line structures numbered 12 and 13 which span Milnor Drain No. 7 in Section 5-132-54. The center line of the transmission line runs parallel to and approximately 55 feet north of the south section line of Section 5. At Central Power's request some of the wording in the permit form was edited by Sean Fredricks, Attorney for the Board. Special Conditions include that Central Power agrees to indemnify and hold harmless the Water Board from any and all claims, etc. and all power poles and anchors shall not be placed within the channel, on the berms, or within 25 feet of the outside berm toe. Motion to approve said permit. (Engst/White, unanimous)

Board members discussed several areas on Drain No. 11 with concerns on culvert installation. Board members agreed that they will not raise any berms for overflowing on legal drains. Motion to visit with Attorney Fredricks regarding a policy for these situations. (White/Engst, unanimous)

Richard explained to Board members regarding the project by Gwinner Airport and the Request to Drain in Highway Right of Way. The contractor was sending the form to Gwinner City and the city should return to the Water Board for their receipt. The form has not been returned.

Mark was contacted that the tower at Frenier Dam was plugged again by the beavers. He will take a look at it. The drift wood that is piled on the land farmed by Jeff Breker will be hauled away when Dave Titus Excavation is in the area.

Roger gave a report on the bus tour with the Red River Basin Commission. A retention dam in Sargent County is being promoted.

Richard presented pictures of the work completed on Drain No. 7 through Milnor City. Some of the areas are FEMA projects.
