Richard Engst reported on the Silver Lake Stabilization Project meeting with the commissioners on November 4. The completed 404-permit application has been prepared and submitted to the ND Regulatory Office. Mr. Rush is hopeful that we can permit this work under the Regional Council's regional general permit or another applicable nationwide permit. The project cost is estimated at \$98,831.30.

Discussed Bridge 114-21 on Drain No. 9 in Taylor Township and reviewed a bid from Dakota Improvement to remove the bridge and install a Texas crossing for \$3,000. Roger is waiting for the Sundale Colony to submit a bid on the project.

Mark, Roger, Richard and Dan attended the forum in Britton, SD to discuss water issues in the south end of the basin, how these issues fit into the larger Red River Basin water issues, and areas where increased cooperation will benefit all involved. Commissioners, Conservation Districts and Water Board/District members attended from several counties in both North and South Dakota. Most were in favor of meeting in the spring in Sisseton, SD to continue discussing these issues.

Mark reported that the work on the outlet to Frenier Dam started on November 10 and refuge employees were on hand to assist. The area was staked out and Sundale Colony began the work under the supervision of Rob Hoflen, Tewaukon Refuge. The work was completed in a couple days and the spoil will be leveled next year. Overall, the project looks good.

The Board discussed the upcoming Annual Water User's convention in Bismarck on December 8-9. The State Water Commission will be meeting and consider funding for the Silver Lake Stabilization project. Other tentative meetings were discussed on those dates in Bismarck.

The meeting adjourned at 9:30 p.m.
