The Meeting was called to order by Chairman William Bosse. Present at the meeting were William Bosse, Ole Breum and Milton Bergsjoe, Commissioners and Ordean Jacobson, SCS Work Unit Conservationist.

The Minutes of the previous meeting were read and approved. Written financial reports for the months of December, 1970 and January and February, 1971 were presented to the Board, which reports were approved by the Board.

It was thereupon moved by Commissioner Breum and seconded by Commissioner Bergsjoe that the Secretary be instructed to contact Mr. Maloy Norby concerning his outstanding account for 1970 crop and land rental. All commissioners voted in favor of this motion, so the same carried and was declared duly adopted.

It was thereupon moved by commissioner Breum and seconded by Commissioner Bergsjoe that the chairman and Secretary be authorized and instructed to sign "Supplemental Watershed Work Plan Agreement No. 4", the purpose of the agreement being to delete 11.2 miles of channel Improvement, known as the "Britton Branch" from the original work plan, Wild Rice Creek Watershed. On roll call vote the following vote was had: Bosse, "aye", Breum, "aye", and Bergsjoe, "aye". No one voted "nay" so the motion carried and the resolution was adopted.

A discussion was then held regarding the annual inspection of the dams and channels located in the Tewaukon and Wild Rice Creek Watersheds. It was thereupon moved and seconded that such annual inspection would be made on April 13, 1971; commencing at 8:30 o'clock a.m., with April 20th as an alternate date of conflicts developed for April 13, and that Richard Moum, SCS Engineer be requested to be present at the inspection. All Commissioners voted in favor of this motion and the same was declared duly carried.

It was thereupon duly moved and seconded that the Sargent County Bank, Forman, ND, be designated as the depository for the funds of the District; and that the pledge of assets heretofore made by said bank to cover excess deposits, dated January 1, 1968; the assets pledged at the present time being: \$50,000, U.S. Treasurer notes 5 3/4%, Series !-1975, 8625/90 10M ea., due 2-15-75; on roll call vote the following vote was had: Bergsjoe, "aye", Bosse, "aye" and Breum "aye", no one voted "nay" so the motion carried and the resolution was adopted.

It was thereupon moved by Commissioner Bergsjoe and seconded by Commissioner Breum that the following bills be approved and paid and ratified:

MINUTES OF THE MEETING OF THE SARGENT COUNTY WATER MANAGEMENT BOARD HELD IN THE OFFICE OF THE SECRETARY AT FORMAN, ND, ON MAY 3, 1971.

The meeting was called to order by Chairman William Bosse. Present at the meeting were: William Bosse, Ole Breum and Milton Bergsjoe, Commissioners, Robert A. Case, Secretary-Treasurer and Mr. Raymond Wiese of Oakes, ND.

The minutes of the previous meeting were read and approved. Written financial reports for the months of March and April, 1971, were presented to the Board, which

reports were approved by the Board.

Commissioner Breum reported that the annual inspection of all dams and channels located in the Tewauken and Wild Rice Watersheds had been made on April 13, 1971, that it was discovered that there was some erosion about one-fourth of a mile North of Dam T-2 which was caused by a spring located in this area. It was suggested that the washed-out area be filled with rock. It was also pointed out that some farmers were farming their land to close to the mitigation ponds located near channel #9, and were not leaving a 10 foot buffer zone; and that the fish and wildlife service was objecting to the practice.

It was thereupon moved by Commissioner Bergsjoe and seconded by Commissioner Bosse that the inspection report by approved and incorporated into these minutes by reference. All commissioners voted in favor of this motion and the same was declared

duly carried.

Commissioner Breum then reported that he had attended the Annual Spring Meeting of the ND Water Management Districts Association held at Carrington, ND on April 16, 1971.

Some of the matters discussed at the convention were the following: The fact that members of Water Management Boards are now entitled to \$15.00 a day per diem, \$15.00 per day expenses while away from home and 10¢ per mile for authorized travel; that the legislative coucil is studying the boundary lines of all Water Management Districts and that the State Board would probably meet in Carrington during July or August.

It was thereupon mobed by Breum and seconded by Bergsjoe that the following

It was thereupon moved by CommissionerBreum and seconded by Commissioner Bergsjoe that the Secretary-treasurer be authorized and instructed to renew his bond and the bond of his secretary for the year beginning July 1,1971 and ending July 1, 1972, in the total amount of \$80,000.00 or \$20,000.00 for each employee.
