The meeting was called to order by Chairman Lien. Those present were: Commissioners Bosse, Jacobson, Paczkowski, Totenhagen and Sherry Hosford, Secretary.

Commissioner Bosse moved that the minutes be approved as distributed. Commissioner Jacobson seconded the motion and same carried.

Commissioner Bosse moved that Sargent County Bank, Forman, ND be designated as the public depository for funds belonging to this Board and that the Pledge of Securities with said bank in the amount of \$200,000.00 be sufficient according to law. Commissioner Jacobson seconded the motion and same carried.

The Application for Abatement and Settlement of Taxes filed by Gerald Nicolai was discussed. Mr. Nicolai did not appear for the scheduled hearing. Commissioner Totenhagen moved that the Board reject the application because on December 18, 1980, a public hearing was held at which time any person could present their views. There was not sufficient opposition to the Water Channel Improvement District No. 1 and the assessments were apportioned according to the benefit factor. Commissioner Paczkowski seconded the motion and same carried.

The Board discussed the bill presented by Arntson, Hagen, Wentz & Klein. The bill was for legal services rendered on the reassessment of Drain No.3 and Drain # 11. The Secretary was instructed to contact Mr. Wentz and ask that he prepare an assessment list for both drains at \$1.00 per acre and that there be no additional cost for such work.

MINUTES OF THE MEETING OF THE SARGENT COUNTY WATER RESOURCE BOARD HELD ON MARCH 14, 1984 AT THE HOUR OF 9:30 A.M. IN THE COMMISSIONERS ROOM OF THE SARGENT COUNTY COURTHOUSE.

The meeting was called to order by Chairman Bosse. Those present were: Commissioners Jacobson, Lien, Paczkowski and Totenhagen, Jeff Volk, Moore Engineering, Inc. and Sherry Hosford, Sec.-Treas.

Commissioner Jacobson moved that the minutes be approved as distributed. Commissioner Paczkowski seconded the motion and same carried unanimously.

Joe Kiefer, Cayuga, met with the Board to discuss a draining problem in Kingston Township. Mr. Kiefer would like to drain a road ditch along a township road (Section 34-Kngton Township) in to Drain No. 3. There is a culvert in the road that needs to be lowered and the township agreed to do this. He explained that there are a couple landowners that are complaining about the possible draining and Mr. Kiefer would like to know if he would be allowed to do this draining. The Board advised Mr. Kiefer to work with the township to be sure that they will lower the culvert. They should send a letter to this Board of their intent to do so. If the area drained is less than 80 acres, the Board has no jurisdiction, but if it is more than 80, an Application to Drain must be filed.

A petition from several landowners in Milnor Township was read by the Board. The request is that a culvert be installed between Sections 10 & 11 in Milnor Township on Old Drain No. 7 to allow access to the land in the NW_4^1 -11-132-54. Commissioner Jacobson moved that the Board approve this request and that the Secretary be instructed to check with the County Commissioners on the possibility of using culverts already in the county's inventory. Commissioner Lien seconded the motion and same carried. The Board will pay 60% of the culvert cost and their share for installation.

Jeff Volk proceeded to discuss two different proposals for Drain No. 11. The North Branch was estimated with a 3:1 Slope and also a 4:1 Slope. The Board feels that they cannot approve an entire clean out, but feel that an annual maintenance assessment should be placed on all land in the district. It was decided to meet with Jeff Volk and Dan Wentz the latter part of this month to discuss a few alternatives.

Commissioner Paczkowski asked what could be done about the hunting at Frenier Dam. The area is posted for "No Hunting", but it is being hunted by some and the area is not patrolled. He wants to know if the signs can be removed. The Secretary will check it out and report back at the April meeting.

MINUTES OF A SPECIAL MEETING OF THE SARGENT COUNTY WATER RESOURCE BOARD HELD ON MARCH 26, 1984 AT THE HOUR OF 1:00 O'CLOCK P.M. IN THE COMMISSIONERS ROOM OF THE SARGENT COUNTY COURTHOUSE.

The meeting was called to order by Chairman Bosse. Those present were: Commissioners Jacobson, Lien, Paczkowski, Totenhagen and Sherry Hosford, Sec.

The purpose of the meeting was to discuss what this Board definitely plans to do in regards to Drain No. $11.\,$

Board members from the assessment area feel that the landowners would vote down a major cleaning. The engineer suggested the possibility of splitting the area into three parts. The Board is not in favor of this idea because when the initial hearings were held it was for the entire drain and it is their feeling that if it was to be split, it should have been done prior to the hearings.

Commissioner Totenhagen mentioned a problem with a landowner along the drain. It is possible this party will be installing a center pivot system and would want an approach across the legal drain. There could be a problem with the installation of culverts. It was suggested that this Board should not allow any approaches on drain right-of-way. No decision made.

The Board must make a decision if they want to spend anymore of the General Levy on Drain No. 11. It was the general consensus that only a small maintenance levy be placed on the land in the assessment district. There are several trouble spots in the south end and it was decided to meet with the engineer to review these areas before making a definite decision on the maintenance levy. Said meeting was scheduled for April 12 at the office of Moore Engineering, Inc.

Commissioner Totenhagen described a problem with a roadway in Whitestone Hill Township. The crossing is located 1/8 mile south of Highway 13 between Sections 25 and 26. The road is holding up the water and it is backing up into B. Rodine's yard. Commissioner Lien moved that the Board grant permission to the township (with an additional letter sent to the City of Gwinner) to put an equalizer culvert in this grade. This placement should be subject to approval from the landowners involved and that they are in favor of same. Commissioner Paczkowski seconded the motion and same carried.

Commissioner Paczkowski relayed a request from Harold Lawrence. Mr. Lawrence would like an approach to cross over Drain No. 3 in Section 28 of Kingston Township. The Board will look at the problem during the annual dam inspection.

Commissioner Paczkowski introduced the following resolution and moved its adoption. Resolution was seconded by Commissioner Jacobson and carried unanimously.

RESOLUTION MERGING SARGENT COUNTY DRAIN NO. 16 INTO SARGENT COUNTY DRAIN NO. 11

BE IT RESOLVED by the Board of Commissioner of the Sargent County Water Resource District as follows:

The Board has completed proceedings for reassessment of benefit of Sargent County Drain No. 11 and has reassessed the benefit of all land determined by the Board to be benefited by Drain No. 11.

The Drain No. 11 assessment district, as constituted after reassessment of benefits, now includes the entire district covered by Sargent County Drain No. 16.

The Board hereby determines that there is no longer a need to maintain Drain No. 16 and Drain No. 11 as separate drainage districts, since the area of Drain No. 16 is entirely overlapped by the area of Drain No. 11.

It is therefore resolved by the Board that the Sargent County Drain No. 16 drainage district is hereby merged into the Sargent County No. 11 drainage district, and that the two drainage districts shall hereafter exist as the Sargent County Drain No. 11 district, with assessments for maintenance thereof to be levied in accordance with the percentages adopted by the Board in connection with the reassessment of the benefit proceedings for Sargent County Drain No. 11.

It is further resolved that the assessment list heretofore adopted by the Board with regard to Sargent County Drain No. 16 is hereby vacated.

OPINION TO WATER RESOURCES MANAGEMENT DISTRICT:

QUESTION: Whether Natural Drains which are located on a parcel of land subject to an easement for Waterfowl management rights may be cleaned out to a depth at which it existed when the easement?

ANSWER: Probably not.

RATIONALE: North Dakota Law 61-01-07 provides that anyone illegally obstructing any ditch drain or watercourse is liable to the party suffering injury from the obstruction and is guilty of a class B Misdemeanor. The first question to be answered is whether or not there is an ILLEGAL obstruction. (Note that the emphasis is on the word "illegal"). An obvious illegal obstruction would exist for example if the drain had been obstructed by the dumping of rocks in the drain way, however where the drain fills in over a period of years due to natural forces such as erosion or the growth and build-up of slough grasses, no person or persons has actively promoted the blockage of the drain. Thus the obstruction is due to natural forces rather than any individual and would become a natural obstruction versus an illegal obstruction.

Secondly, the contractual obligations in most Waterfowl easements prohibits any further drainage or cleaning of drains on the entire tract of land and not just the low lying areas. (Note the actual descriptions of easement recites the entire tract of land). The typical contractual obligations read as follows:

The parties of the first part, for themselves and for their heirs, successors and assigns, covenant and agree that they will cooperate in the maintenance of the aforesaid lands as a waterfowl production area by not draining or permitting the draining, through the transfer of appurtenant water rights or otherwise, of any surface water including lakes ponds, marshes, sloughs, swales, swamps, or potholes, now existing or recurring due to natural causes on the above-described tract, by ditching or any other means; by not filling in with earth or any other material or leveling, any part or portion of the above-described tract on which surface water or marsh vegetation is now existing or hereafter recurs due to natural causes

Once again the important verbage is "sloughs, swales, swamps, or potholes now exixting or recurring due to natural causes." The above language effectively prohibits any drainage on the entire tract (excepting possibly for illegal obstructions).

The meeting was called to order be Chairman Bosse. Those present were: Commissioners Jacobson, Lien, Paczkowski and Totenhagen, Jeff Volk, Moore Engineering, Inc. and Sherry Hosford, Sec.

Commissioner Lien moved that the minutes be approved as distributed. Commissioner Paczkowski seconded the motion and same carried.

Tim Mueller and John Quincy, North Dakota Parks and Recreation Dept. met with the Board to discuss the Head of the Mountain Nature Preserve near Frenier Dam. They asked what was the Board's feeling in regards to hunting the preserve. It is felt that it should be open to everyone or closed and patrolled. Mr. Quincy stated that he had checked the preserve area in November prior to hunting. Mr. Mueller informed the Board that if they want to allow hunting, there would have to be a public meeting to amend the Articles of Dedication. The Dept. agreed to contact local game wardens prior to deer season and also the refuge manager to keep the area closed. They will also meet with the wildlife clubs in the area and remind them that the preserve is closed to hunting. If this does not work, next fall the Dept. will come back and have a public meeting. They also discussed placing a large sign near the gate of the preserve stating the purpose and provisions. The Dept. will also get it fenced as specified in the Articles of Dedication.

Commissioner Paczkowski moved that the Board adopt the following Priority List for the 1985-1987 biennium as requested by the State Water Commission. Commissioner Jacobson seconded the motion and same carried. No. 1 - Structure Improvement on Wild Rice River Basin; a. Tributary structures-\$500,000.00-\$750,000.00; b. Main stem structures-\$1,000,000.00-\$1,500,000.00; No. 2 - Reconstruction of Sargent County Drain No. 11 - Beginning in Section 23-132-58 and running through Section 8-129-56-\$1,500,000.00; No. 3 - Inventory, sizing and evaluation of the placement of all culverts, bridges and structures and prioritizing replacement, resizing and removal-\$150,000.00; No. 4 - Preliminary engineering of water channels and drains located in the Sargent County Water Resource District-\$50,000.00.

A complaint filed on April 2, 1984 from William Nathe concerning water backing up in the NW_{4}^{1} of Section 2-130-55 was discussed by the Board. Commissioner Totenhagen moved that a letter be sent to Mr. Nathe with the following determination: The Board had investigated the problem and noted that there were several places where obstructions are restricting the flow of water, namely, a culvert on Old Highway No. 11 on the southside and a culvert under the railroad tracks which has some trees and debris covering the opening. It is the Board's determination that if the culverts were cleaned and opened to their capacity, the water would flow more freely solving the backup problem. It is the landowners obligation to keep a natural drain clean. Commissioner Lien seconded the motion and same carried.

The Board discussed Drain No. 3 and the problem with water running into Sargent County from Richland County. There are ten sections in Richland County which contribute to Drain No. 3. In a discussion with Richland County Water Board, it was noted that there was a Bi-County Drain at one time that included that area. It was decided to check the old records for any information on the Bi-County Drain.

A request from Clinton Greenley to install a culvert in the \mathbb{E}^1_{Ξ} of Section 24-132-57 and the \mathbb{W}^1_{Ξ} of Section 19-132-56 was discussed. Commissioners Lien and Totenhagen will go out and investigate the area and report at the May meeting.

The following bills were audited. Commissioner Jacobson moved that the bills be paid. Commissioner Totenhagen seconded the motion and same carried unanimously.

The Board discussed the status of reassessment on Drain No. 3 and decided to table until such time they can speak to Attorney Wentz.

Commissioner Paczkowski moved that Commissioner Lien represent Sargent County on the Tri-County Water Resource Board Executive Committee. Commissioner Totenhagen seconded the motion and same carried.

Chairman Bosse reported that he had received a phone call from William Huffman regarding excessive pumping from Lloyd Ptacek's irrigation pump into the road ditch flooding the Huffman pasture. Bosse looked at the problem and learned that the State Water Commission had been pumping on Ptacek's system into Drain No. 11. Several holes were dug and they were monitoring how much it lowered the acquifer. The water run for 4 days, then it was shut off and checked to see how long it took to replenish. It was the Board's opinion that they should have received notification from the State Water Commission prior to the test so that they were aware of what was being done.

The 1984 assessment for Drain No. 11 was discussed and the Board decided to contact a contractor and set up a meeting date to discuss the trouble spots and get price estimates of the work that would be necessary. The Secretary was also instructed to contact Jeff Volk and request that he send copies of the surveys to this office, so that the contractors may use them to check elevation.

The following bills were audited. Commissioner Lien moved that the bills be paid. Commissioner Paczkowski seconded the motion and same carried unanimously.

Commissioner Jacobosn moved that this Board pay the balance due on the 1979 assessment, including interest and penalty. Commissioner Lien seconded the motion and same carried.

Dennis Brezicka and William Nathe discussed a problem with a natural waterway and plugged culverts. The Board explained that it is the landowners responsibility to maintain and clean a natural waterway. The land that is causing the problem has easements and it was not known if easement land can be cleaned and drained. The Board instructed the Secretary to seek an opinion from the States Attorney and send a letter to Dunbar Township informing them of the outcome. The Board also agreed to go one-third of the total cost of a culvert that needs to be replaced in that same area. (SW_4^1 -Section 35 - Dunbar Township)

Greg Radniecki, Thief River Falls, met with the Board and presented price proposals on several projects in Sargent County. Commissioner Lien moved that the Sargent County Water Resource Board hire Radniecki and Jensen Construction Co., Inc. to install two 96" culverts and put three 72" extensions on the determined locations. Commissioner Jacobson seconded the motion and same carried. Mr. Radniecki agreed to place the order for 2 - 10' 72" extensions and 1 - 12' 72" extension. The county will participate in the cost of the culverts at 40%.

The Board reviewed an Application to Drain from Raymond Zajac, Lidgerwood, ND. The proposed drainage will flow into the Tri-County Drain. Commissioner Paczkowski moved that the Board refer said application to the Tri-County Drain Board for their consideration. Commissioner Totenhagen seconded the motion and same carried.

The Board proceeded to discuss the decisions made with the County Commissioners on Tuesday, June 19. The Rutland culvert will be cost shared with the county at 60/40 for a 30 inch culvert, the county will provide the gravel and the City of Rutland shall do the removing and installing of the culvert. On County "K", two 96 inch pipes will be installed, one 33', one 12' and two 12' beveled at each location. The culverts will be cost shared at 60/40, the Water Board will pay for installation and the county will provide gravel for installation, gravel for the road top and deliver the pipe to the site. On the Methorst Bridge, a 60" pipe will be cost shared at 60/40. The township agreed to do the dirt work and possibly tear out the old bridge and pay for the gravel.

The Board approved a request from Rutland City to clean trees out of the ditch on the north side of the county road to the beginning of Drain No. 8.

The Board proceeded to work on the budget for July 1, 1984 through December 31, 1984. Commissioner Jacobson moved that the Board submit a total budget for the six-month period for \$27,450.00 to the Sargent County Board of Commissioners. Commissioner Lien seconded the motion and same carried.

MINUTES OF THE MEETING OF THE SARGENT COUNTY WATER RESOURCE DISTRICT HELD ON WEDNESDAY, JULY 18, 1984 AT THE HOUR OF 8:00 P.M. IN THE COMMISSIONERS ROOM OF THE SARGENT COUNTY COURTHOUSE.

The Sargent County Water Resource Board met pursuant to adjournment with the following persons present: Commissioner's Bosse, Jacobson, Lien and Totenhagen; Randy Gjestvang, SWC; Lyle Bopp, States Attorney; Greg Radniecki, Radniecki and Jensen Construction; Jeffrey Breker, Donald Markeseth and Sherry Hosford, Secretary.

Commissioner Jacobson moved that the minutes be approved as distributed. Commissioner Lien seconded the motion and same carried.

Randy Gjestvang, State Water Commission, introduced himself to the Board. He is stationed in West Fargo and will be working with projects directly involved with the Red River Joint Board. He assured the Board that he will offer any assistance that he can and asked that he receive a copy of each month's minutes to keep him updated on what is happening in Sargent County. Permission granted.

Lyle Bopp, States Attorney, presented an opinion to the Board relative to whether natural drains which are located on a parcel of land subject to an easement for waterfowl management rights may be cleaned out to a depth at which it existed prior to the easement. Mr. Bopp felt that it could not legally be cleaned out. A copy of the opinion is attached for future reference.

The Board discussed the problem in Dunbar Township regarding the natural drain and Commissioner Jacobson agreed to talk to the parties affected before this Board would recommend any action be taken.

Greg Radniecki discussed the structure removal and replacement project which has been completed. The Stations affected are: 818, 845, 910, 917 and 764.

The Board discussed with Mr. Radniecki the possibility of cleaning out approximately $3\frac{1}{2}$ miles in the South Branch of Drain No. 11. Mr. Radniecki assured the Board that this could be accomplished by his company. Commissioner Jacobson moved that the Board proceed with cleaning $3\frac{1}{2}$ miles in the South Branch. Commissioner Lien seconded the motion and same carried.

The North Branch of Drain No. 11 was also discussed and Commissioner Totenhagen moved that the Board approve cleaning $4\frac{1}{2}$ miles in this area. Commissioner Lien seconded the motion and same carried. Radniecki and Jensen will do said work.

The farm contracts for the ensuing year were discussed. Donald Markeseth and Jeffrey Breker are renting the land now. The Board explained that they plan to raise the price per acre and offer the tenants longer leases. There was no objec-

tion from either party. Commissioner Lien moved that the Board raise the rent to \$35.00 per acre and that the term of the contract be extended to five years. Commissioner Totenhagen seconded the motion and same carried. The term of the contract will expire on October 1, 1989.

Commissioner Lien moved that the Board approve the Pledge of Assets as securities according to the laws of North Dakota. Commissioner Totenhagen seconded the motion and same carried.

A copy of the annual dam inspection was reviewed by the Board. The following is a summary of needs for maintenance: T-1A-Lubke-Brummond Dam. Minor fence repair needed along the top of the dam to keep livestock off the spillway and face of the dam. T-&-Nelson Dam: First stage spillway inlet at the base of the riser is plugged up. Dam is, therefore, holding more water than normal. This should be unplugged so that the dam will have the necessary storage capacity in case of flood. Also, water will not go through the emergency spillway which could possibly erode it or cause flooding downstream. Tewaukon Channels 1,2, & 3: Trees and brush need to be sprayed again at several locations, especially in # 1. New chemical used last year was not effective in all cases, especially on Russian Olive trees. Wild Rice Channels 1 & 9: Trees and brush again need to be sprayed for same reasons above. General Comments: Burn channels every few years to remove excess litter and improve grass vigor. Good recovery of vegetation on bare areas at Lubke-Brummond dam. Landowner needs to keep grazing lightly on these sandy areas as he is doing now because vegetation is easily destroyed on these areas. Need to keep advertising about channel right-of-ways and encouraging landowners not to farm too close to the channels.

The Board discussed seeking assistance on the replacement of the bridge located at Station 818. It was agreed to contact the Soil Conservation Service and request that they take a couple shots with the transit to insure that placement is done correctly.

The following bills were audited. Commissioner Totenhagen moved that the bills be paid. Commissioner Jacobson seconded the motion and same carried unanimously.

The Sargent County Water Resource Board met pursuant to adjournment with all members present.

RESOLUTION REVISING RE-ASSESSMENT OF BENEFIT AS TO CERTAIN LAND

The Sargent County Water Resource Board has made a determination as to the area benefited by Sargent County Drain No. 11 and has reassessed the benefits of said Drain No. 11, upon publication of a list of percentage of benefit as to each tract of land benefited thereby and upon a public hearing called for the purpose of hearing objections to the reassessment of benefits.

Subsequent to completion of the reassessment of benefits proceedings, the Secretary of the Board has determined that the property located in Section 25, Vivian Township, which is included in the assessment district, is described in the reassessment list as one entire parcel, being 297.19 acres North of the Railroad in the South Half of said Section 25, with a single percentage of benefit figure shown for the entire tract, and that for the purpose of convenience in spreading assessments for maintenance of Drain No. 11, the tracts in the Southeast Quarter and the Southwest Quarter of said Section 25 should be described on the list and assessed separately.

The Sargent County Water Resource Board met pursuant to adjournment with all members present.

Commissioner Jacobson moved that the minutes be approved as distributed.

The Board proceeded to hold an informal hearing on a complaint filed by Harvey Shasky. The Board has made a determination that the approach should be removed or a 24" culvert placed in the approach. The Rutland Township Board replied that they had sent a letter to Roger Hom to either remove the approach or install a 24" by 30' culvert. The 24" culvert would equalize with the upstream culvert. The Township also replied that if the approach were moved further east, no culvert would be necessary and it would provide easier access to the road from the field. Mr. Hom had no comment at this time. Mr. Shasky remarked that the approach is an obstruction and should be removed. The Sargent County Water Resource Board moved to send certified letters to all parties concerned with their final determination following the investigation on October 8, 1984. (Others present during the informal hearing were: Harvey Shasky, Paul Shasky, Roger Hom, Lillian Hager, Larry Nelson, Duane Lock, Clayton McDaen and Lyle Bopp, States Attorney). Deadline shall be November 24, 1984.

Roger Hom presented a complaint on a plugged drain located in the West 57 acres of Section 16-130-55. Said drain was plugged in October, 1983 and is causing noxious weeds to grow and spread seeds on Mr. Hom's land and all adjacent land. The Board accepted and filed the complaint and will investigate and make a determination at a later date.

The Board discussed Drain No. 12 and authorized the cleaning of 200 to 300 feet in the center of the drain. Commissioner Paczkowski will contact a contractor.

The Cayuga Sewer Project was discussed and Commissioner Jacobson moved that the Secretary send a letter to Mr. Richard Lane, Lightowler Johnson Associates, asking him to inform the Board on the status of required flowage easements pursuant to the conditional permit dated February 17, 1983.
