After much discussion, the group agreed to meet on June 30th and review a design proposal by Mr. Volk and Mr. Backstrand. RE: Drain # 11

Jim reported that Nelson Dam has water running out of the pipe. After it quits running, they can weld, haul in rocks and install the tank.

A problem on Drain # 8 was discussed. The Gwen Young driveway (south edge of Rutland) is deteriorating and needs new culverts or extensions and some work on the approach. The county road superintendet will be contacted to measure the culverts and this Board will meet with the county commission to discuss improvements.

Donald Kiefer, Archie Paczkowski and Harry Kiefer arrived at the meeting to discuss a drainage complaint filed by Donald on April 14, 1993. After much discussion it was agreed to try an experiment with a restrictor gate on the 42"x64" squash pipe in the NE½-13 Tewaukon Township. This gate would hold water in said section until the water drains below. Also will consider a flapgate on the 42" round culvert under County Road # 5 between Sections 6 & 7 of Marboe Township. Board members will meet with the county commissioners on July 6th to discuss the above proposals.

NEW BUSINESS:
The Board reviewed the Annual Dam Inspection report presented by SCS. Some improvements were seen on the WR#1 channel as the trees have been sprayed and are dead but some small willows remain in WR#2. All channels have scattered patches of leafy spurge and all are choked with cattails with the exception of Bergh-McLaen. Bergh-McLaen continues to improve with the sediment in the plunge pools cleaning out. The three dams - Brummond, Frenier and Nelson have a fair quantity of water in them with water going through the pipe outlets. Only Brummond dam area needed some work and that being a new culvert pull in a crossing on the downstream channel and to have the fence fixed where a couple of broken wires on the embankment were found.

Chairman Jacobson called the meeting to order with the following members present: Bosse, Totenhagen, Lien and Paczkowski. Absent: None. Also present: Wallace Johnson, Donald & LuVerene Colby, Myron & Alvin Yagow, Thomas & Marvin Mund and Harold Asche.

Approved July 15, 1993 minutes and financial statement. (Lien/Totenhagen, unanimous)

Wallace Johnson is having water problems in the SW $\frac{1}{2}$ -12-132-54. He feels SC Water Channel Imp Dist. # 1 is more of a trap than a drain because the water does not flow down the drain. There is a 24" culvert under the state highway and another on the north/south township road that could use a trap to keep the water from backing up on Mr. Johnson. The Board agreed to contact the Fargo District NDDOT and ask them to come and take a look at the problem.

The Colby/Yagow drainage complaint filed on July 28, 1993 was discussed. No permit has been approved for the NE½-33-132-55 and water from said quarter is affecting land owned by the Colby's. In 1987 this Board instructed the Yagow's to install controls to eliminate the impact on Colby. The controls are in place but are turned down. The Board requested that the Yagows keep the controls in a vertical position except when Yagows can hold water on their own land. This should be completed by September 1, 1993 and this Board will inspect after that date.

The Mund/Yagow drainage complaint filed on July 20, 1993 was discussed. The Water Board determined that Mr. Mund did not have a standing to file a complaint because they cannot prove that any new or additional drainage has been done in recent years. All the tile was in place when Tom Mund purchased the land and if the culvert under the township road needs replacing the township board should get permission from the Water Board before any changes are made.

The Mund/Asche drainage complaint filed on July 20, 1993 was discussed. The Water Board feels if the culvert size was not changed in 1989, there is no standing to file a complaint. Tom Mund feels the culvert was 30" and replaced with a 36" and Mr. Asche claims it was always a 36".

Dan and Jim reported that the work on Nelson Dam is completed and also a $24" \times 20"$ culvert was installed by Boyd Brummond's. Jim is working on the Ray Armer problem with the beavers.

Discussed work on Drain No. 12 and Mike feels a backhoe will work better. He will get some estimates and try to get work done this fall. Approved 1993 levy at \$.50 per acre. (Bosse/Totenhagen, unanimous)

Drain No. 11 lawsuit - working on a mediation process.

Read a letter from RSR regarding locations where the electric power lines are parallel to the drainage ditches or crossing a ditch. They are concerned for the safety of the workmen and ask that we cooperate in contacting them to de-energize the power line before doing the work.

Red River Joint Water Board request for 1994 budget from Sargent County is \$5,746.80.

A Texas crossing between Sections 31 & 36 of Tewaukon needs rock and repair. The Board agreed to a 50/50 cost share with the county commission to repair the crossing.

Chairman Jacobson called the meeting to order with the following members present: Bosse, Lien, Paczkowski. Absent: Totenhagen.

Approved August 19, 1993 minutes and financial report. (Bosse/Paczkowski, unanimous)

Approved reinvesting CD #630216 for six months. (Paczkowski/Bosse, unanimous)

Daro Crandall and Kevin Moxness, Herman Twp Bd of Supervisors arrived at the meeting to discuss a water problem between sections 7/8. The end of July there was water over the road and to save their road, they dug out an approach (with no culvert) and drained the area. The water drained to the north into a drain field by Arlin Mund's and did not affect any downstream landowners. Mr. Mund would like the approach put back in and the township would like to install a culvert to eliminate future problems. Approved placing an 18" culvert in the approach at ditch bottom. (Bosse/Paczkowski, unanimous)

Robert Nelson and Alten Crandall arrived at the meeting to explain a complaint which they filed with the Board on 8-31-93. In the SW½-23-131-53, the landowner has pushed rocks into the river and placed a dam across the entire width of the river. This affected 640 acres of land, roads were underwater, culvert washed out and several acres of pasture land was flooded. The Water Board stated that we have a policy not to dump rocks and debris in waterways/rivers and agreed to contact the landowner requesting the rocks be removed by October 15th. (Lien/Bosse, unanimous)

Kim Beckstrom and Bill Kuzoh, Dakota Landfill, met with the Board to discuss a drainage application. They are proposing a new road to the landfill (from Rich Beaver's west 2 miles and North&1/4 mile) because of complaints from landowners on the present road. They plan to widen this roadway and possibly pave if tonnage per day increases. They won't be draining wetlands but will be filling wetlands. A draft of an application to drain a wetland was presented by Kim and they agreed to meet with the State Water Commission to discuss the necessity. The Water Board feels it will be necessary to apply for a 404 permit and Mr. Kuzoh informed them that the engineer is looking into the permit process. The Water Board agreed to wait until the two of them meet with the SWC to see if this board has any jurisdiction.

Jim reported on the beaver problem. They have cleaned out three times and it has filled in three times. Plan to wait for freeze-up and go out to beaver hut and trap.

Letter from Mr. Breitling informed the Board that he will represent them on September 17th in Minneapolis with the mediator and other attorneys.

Jeff Breker talked to Dan, Jim and Mike about sizing a culvert in Tewaukon Twp near Ted Lee's driveway. The Board inspected the area and approved placement of a 24" culvert in the Lee driveway and placing an 18" pipe in the township road with a cap. The location is the NE½-3.

Discussion on City of Havana tile drain. They must obtain flowage/flood-age easements and record them before they can proceed with the project.

The Board suggested additional culverts in County Road # 12 to solve the problem. They will meet with the county commissioners on Nov. 2nd to discuss the problem and come up with a solution.

Mike reported Drain # 12 cleanout is complete and it looks good.
