MINUTES OF THE REGULAR MEETING OF THE SARGENT COUNTY WATER MANAGEMENT
DISTRICT BOARD HELD AT THE OFFICE OF ROBERT A. CASE, AT THE HOUR OF
9:00 o'clock A.M., ON MANDAY, THE 5TH DAY OF AUGUST, 1963.

Members present were: Wm. Bosse, and Ole Breum; also present was Robert A. Cas, Sec'y-Treas. and Contracting Officer. The meeting was called to order by Chairman Wm. Bosse.

The Minutes of the previous meeting were read and approved. The Treasurer presented a monthly financial report to the Board which was approved.

It was thereupon moved by Member Bosse and seconded by Member Breum that the bids received in regard to Channel #1, Tewaukon Watershed be cancelled and rejected for the reason that they were too high, being considerably in excess of the engineer's estimate, all as shown by the minutes of the meeting held on Jul 8, 1963. Motion carried.

A general discussion was held by the members present, and the Sec'y Treas. and Contracting Officer regarding various subjects, including the progress that was being made in regard to the purchase of certain Indian Lands, and the Secretary reported to the Board that the Indian Lands in question were being reappraised and that apparently some progress was being made by the Bureau of Indain Affairs in regard to this purchase. A discussion was also held regarding the progress being made on Channel #1 Wild Rice Creek Watershed.

The Sec'y-Treas. was then requested to make inquiry of the Sargent County Bank regarding transfer of the District's checking account to that bank. Because of the gact that the District has a \$10,000.00 Certificate of Deposit with the Sargent County Bank, the Board members were of the opinion that the Secretary should make sure that any additional deposits would be covered by FDIC insurance.

It was thereupon moved by Member Breum and seconded by Member Bosse that the following bills be approved:

Members present were: Wm. Bosse, Milton Bergsjoe and Ole Breum. Also present wreeRobert A. Cas, Sec'y-Treas. and Contracting Officer, and Harold Jelleberg, Work Unit Conservationist and Ed Kubler, Profect Engineer; Tewaukon Watershed.

Mr. Harold Jelleberg gave a report to the Board concerning recreational provisions now included in Public Law 566. It was thereupon moved by Member Breum and seconeded by Member Ber Bergsfoe that the Board look into the possibility of developing recreational areas in regard to other profects in the Tewaudon Watershed. Upon voted this motion carried and the resolution was adopted.

The Secretary reported to the Board that he had advertised for approximately 84 ton of hay to be used as mulch on Dam T-1A, and that he had received the following bids: Irving Weber, Havana, North Dakota, \$16.90 per ton: and L. F. Bergh, Forman, North Dakota, \$16.00 per ton.

Mr. Jelleberg then reported to the Board that he had inspected the hay owned by Mr. B rgh and Mr. Weber and that the inspected hay won ed by each party was acceptable. It was thereupon moved by Member Bergsjoe and seconded by Member Breum that this Board recommend to the State SCS Office that the bid of L. F. Bergh to furnish hay for mulch for Dam T-1A be accepted. On roll call vote all member voted "aye" so the motion carried and the resolution was asopted.

After some discussion the Board indicated to Mr. Jelleberg that they would prefer that grass seed and fertilizer for seeding Dam T-lA be secured separately and, if possible, from local people, rather than to icclude these items in the bid for seeding the said damsite.

The Sec'y-Treas. then reported to the Board that the had consulted with the Officers of the Sargent County Bank, and had been informed that if the Board's checking account was deposited in said bank, that it would be covered by FDIC insurance.

It was then moved by Member Bergsjoe and seconded by Member Bosse that the Sec'y-Treas. transfer the Board's checking account from the Bank of North Dakota to the Sargent County Bank as soon as practicable, and that the Sec'y-Treas. also proceed as soon as possible to change the name of the organization from Sarent County Water Conservation and Flood Control District to the Sargent County Water Management District, and to secure new letterheads with this name, and do everything necessary to effect such a change of name. On roll call vote all members voted "aye" so the motion carried and the resolution was adopted.

It was thereupon moved by Member Bosse and seconded by Member Bergs foe that the Board delegate Mr. Harold Jelleberg the responsibility of finding suitable rocks and to do everything else that might be necessary to complete the Texas Crossings on Channel 1, Wild Rice Creek Watershed, and that Mr. Jelleberg be authorized to deal with Mr. Earl Parrow of Havana, North Dakota, in this regard. Upon vote this motion carried.

It was moved, seconded and passed to adjourn.

It was reported that the engineer's estimate for the cost of the project was \$20,863.60. A discussion was then held with the SCS personnel relative to the qualifications of the low bidder and the bid amount in relation to the engineer's estimate. It was thereupon moved by Member Breum and seconded by member Bergsjoe that the Secretary be instructed to wrete to the State SCS office explaining that it was the position of this Board that the low bidder was a reponsible bidder and had the necessary equipment to do the job but that the bids received were to high and to far in excess of the engineer's estimate and that this Board recommends that the bids be refected. On roll call vote all members voted aye so the motion carried.

It was thereupon moved by member Berfsjoe and seconded by member Breum that the State SCS office also be informed that it was the opinion of this Board that if the profect (Channel #1, Tewaukon Watershed) be readvertised, that the performance time be extended beyond the previous 60 day limit and that time be allowed for moving equipment to the job in establishing performance time. On roll call vote all members voted "aye" so the motion carried.

The Board and SCS personnel then discussed the matter of seeding dam site T-1-A, Tewaukon Watershed. It was thereupon moved by member Breum and Seconded by member Bergsjoe that the Secretary and Contracting Officer write to the State SCS office and ask their assistance in advertising for bids in connection with the seeding of dam T-1-A, and that because of the short season that the bidsibe opened earlier than usual and that if possible that bids on this work be opened on Oct. 7, 1963 at the hour of 10:00 o'clock. On roll call vote all members voted "aye" so the motion carried.

Mr. Rex Barnes mde a report to the Board relative to title status of certain Indian Lands that the Board had previously offered to purchase from certain Indian owners. Mr. Barnes reported that the appraisal on the property has been chande as follows, to-wit: Drocont

Mr. Rex Barnes then proceeded to make a further report to the Board regarding the title status of the above described Indain Lands, as Follows: He Reported that a fee patent could be secured in repect to Allotment #692 and that no guardianship proceedings would be necessary in respect to this allotment, and that if the owners were cooperative the fee patent could probably be secured within thiry days. He reported further that there was no outstanding lease on this parcel.

That a deed would have to secured in respect to Allotment #691, and that one of the owners of this parcel was a minor; that there was an outstanding lease on this parcel, which would expire September 30, 1965.

That the sole owner of Allotment #372 had signed a consent, and that there was no reason why the purchase of his parcel ould be delayed longer than thirty days.

That one of the owners of Allotment #681 was a minor who would obtain majority on January 4, 1964, and that there was no outstanding lease on this allotment.

That a fee patent could be obtained on Allotment #814 (SWof SW 14 -9), that there was an outstanding lease on this parcel which would expire October 1, 1964, and that if the owners were longer than thirty to forty-five days.

That a fee patent could be secured in repect to the SW_{2}^{1} of 9-129-54 LTL, and that the title to this property was very much in doubt and it would be some time before the owners could be legally determined.

Mr. Barnes also reported to the Board that federal law provided that 100% of all minerals be reserved in all transactions involving Indian Lands where the owners of all the above described tracts if the Board would go along with 100% mineral reserved by the woners.

Mr. Ed Kubler then reported to the Board that the final pay estimate for Dam T-1A had been prepared and sent to the State Office, and that upon approval of the same by the State Office, final payment for Dam T-1A would be made.
