The minutes of the previous meeting were read and approved. The Secretary

presented a written financial report to the Board, which was approved.

It was thereupon moved by Commissioner Bergsjoe and seconded by Commissioner Breum that the Secretary-Treasurer be also authorized and instructed to pay William Clairmont, Inc. the sum of \$1,272.64 as this Board's share of the cost of constructing road on East Dike of Spillway, Dam T-2 (3977 cubic yards at 32¢ per yard); the said amount to be paid whenever the final pay estimate has been approved by the State SCS Office.

Mr. Ed Kubler reported to the Board that the final total contract price on Dam T-2 was \$148,175.84.

It was thereupon moved by Commissioner Bergsjoe and seconded by Commissioner Breum that the Pledge of Assets made by the Sargent County Bank of Forman, North Dakota, on March 30, 1964, to cover deposits over \$10,000.00, the same being \$50,000.00 U. S. Treasury Bonds in 1968, #20671/75 @ 10M ea., be approved by this Board. On roll call vote all Commissioners voted in favor of this motion so the same carried and the resolution was adopted.

It was thereupon reported by Mr. Jacobson that the State SCS Office proposes a workshop for Water Management Districts, the same to be a two day meeting tentatively planned for Bismarck in mid March. It was thereupon moved by Commissioner Breum and seconded by Commissioner Bergsjoe that this Board recommends that such a workshop be held. All Commissioners voted in favor of this motion so the same carried.

A discussion was then held regarding the repair of Silver Lake ${\tt Dam.}$ It was moved, seconded and passed to adjourn.

- (c) Reduction of overall cost of project by approximately \$25,000.00.

The minutes of the previous meeting were read and approved. The Secretary-Treasurer presented a written financial report to the Board, which was approved.

The Secretary reported to the Board that all easements had been secured in regard to Channel #9, and that the easements had been delivered to the Register of Deeds for recording.

 $\operatorname{Mr}_{ullet}$ Ordean Jacobson reported to the Board that the time for the work shop of Water Management Districts to be held at Grand Forks, has been changed to March 16 and 17, 1966.

Milton McLaen, Clifford Nelson and Allen Nelson, farmers living in the vicinity of Dam T-2, Tewaukon Watershed, then came to the meeting and reported to the Board that thawing and freezing conditions had created a flooding problem at farmstead below Dam T-7, partly due to orifice flow through the dam, and requested that a gate be installed in the orifice of the dam to control the flow of water during spring thaws. A discussion was then held regarding this matter.

It was thereupon moved by Commissioner Breum and seconded by Commissioner Bosse that a request be made to the State Soil Conservation Office for permission to install a gate on ofifice of Dam T-7 to control the flow of water during spring thaws. On roll call vote all commissioners voted "aye" so the same carried and the resolution was adopted.

The Secretary then reported to the Board that the following bids were on file in respect to the seeding of Dam T-2:

It was thereupon moved by Commissioner Breum and seconded by Commissioner Bosse that the Secretary publish notices for bids in the Sargent County News and the Sargent County Teller, as follows: One notice for bids for the laying and furnishing of 4146 sq. ft. of liva sod on embankment of Dam T-2, Tewaukon Watershed and one

notice for bids for preparation, fertilization and seeding of grass mixture on approximately 27 acres of dam embankment, spillway and borrow area on Dam T-2, including the application of vegetative mulch over the seeding on approximately 22 acres, including the embankment, spillway and steeper slopes and other exposed areas; both of said notices to provide that the bids will be received until March 18, 1966, at 5:00 o'clock P.M. and that all work must be completed by May 1, 1966.

On roll call vote all Commissioners voted "aye" so the motion carried and the resolution was adopted.

It was thereupon moved by Commissioner Bosse and seconded by Commissioner Breum that the following resolution be adopted:

Be it resolved, that the Sargent County Water Management District of Sargent County, North Dakota, does hereby grant and convey unto the Wild Rice Soil Conservation District of Sargent County, North Dakota, authority and approval to design and construct water storage facilities within said Water Management District when said storage facilities has a total storage of $12\frac{1}{2}$ acresfeet or less, pursuant to the provisions of Section 61-16-15 of the North Dakota Century Code.

Be it further resolved, that a copy of these minutes and a letter outlining the substance of this resolution be sent to the said Wild Rice Soil Conservation District notifying the said district of this resolution.

On roll call vote all Commissioners voted "aye" so the motion carried and the resolution was adopted.

A general discussion was then held by those present concerning maintenance problems in respect to the various dams and channels that had been constructed throughout the district.

MINUTES OF THE REGULAR MEETING OF THE SARGENT COUNTY WATER MANAGEMENT BOARD HELD ON THE 7TH DAY OF APRIL, 1966, AT THE HOUR OF 8:00 O'CLOCK P.M., PURSUANT TO ADJOURNMENT FROM APRIL 4TH, 1966.

The Board held a joint session with the Board of Managers of the Wild Rice Creek Watershed District at the Soil Conservation Office at Britton, South Dakota. Present were: Dean Purrington, S. Dak. Area Conservationist; Robert Girard, S. Dak. State Administrative Officer of the Soil Conservation Service; Walter Parmeter, SCS Agronomist; Mr. LeRoy Mernaugh, SCS Engineer, Mr. Lloyd Duerre, Work Unit Conservationist, Britton; Mr. A. William Spiry, Contracting Officer; Board members present were: Ole Breum and William Bosse, and also present were Robert A. Case, Secretary-Treasurer and Contracting Officer; Ordean Jacobson, Work Unit Conservationist, and Ed Kubler, Project Engineer.

Mr. LeRoy Mernaugh then discussed the matter of errosion that had taken place on certain inlets on Channel #1, Wild Rice Creek Watershed. He stated that the SCS would assume the responsibility for correcting five (5) of the errosion situations, as follows:

Station 453+45 Pipe drop and a small amount of earthwork.

Station 480+31 or

484+58 Repairs will only be made at one location, and both drainage areas will be combined. A pipe drop will be

installed below a diversion ditch.

Station 518+79 Pipe drop and earthwork.

Station 518+84 & We will provide a pipe outlet at 528+08 that will serve both locations if the field crossing is closed and a ditch constructed through the field for the county road

drainage.

Station 550+71 Pipe drop and earthwork.

It being estimated that all the cost of this work would be approximately \$3,094.82 He stated further that two of the problem situations - one at Station 457+38, which is located about 400 feet North of the county line on the East side of the ditch, and a second one l mile North of the State line at road ditch, involve very small watersheds and for that reason the Government would not assume responsibility for the correction. He stated further that these situations could probably be corrected by the installation of a 12" culvert and that the probable cost of the purchase and installation of these culverts would be \$719.04.

A discussion was then held regarding the Operation and Maintenance Agreement for Channel #1, Wild Rice Creek Watershed. It was brought out that such an agreement should have been signed by the Chairman and Secretary of the Sargent County Water Management Board back in 1961. Through oversight this was not done. Mr. Robert Girard then stated that the Soil Conservation Service was prepared to go ahead with the repairs to the errosion on Channel #1, as outlined by Mr.

Mernaugh, whenever the Operation and Maintenance Agreement was signed by the

Sargent County Water Management District Officers.

Mr. Lloyd Duerre then stated that it appeared that the slopes on Channel #1 for about $4\frac{1}{2}$ miles North into North Dakota, needed reseeding. He stated that he believed the cost of reseeding would be a Government cost. It was then brought out by the South Dakota Soil Conservation Service personnel that the service would be willing to reseed these slopes one more time, but they did not want to come back and do this work every year; and apparently that the lack of vegetation was caused by overgrazing.

Mr. Duerre then stated that the annual inspection of Channel #1, Wild Rice Creek Watershed had been tentatively set for the afternoon of May 6th, 1966.

The Sargent County Water Management Board then met separately for the purpose

of donducting its regular business.

The meeting was called to order by Chairman Wm. Bosse. The Secretary-Treasurer presented a written financial report to the Board, which was approved.

Mr. Ed Kubler then asked the Board to consider the question of the time for

inspection of all Tewaukon Watershed dams and channels.

It was thereupon moved by Commissioner Breum and seconded by Commissioner Bosse that this Board make an inspection of all dams and channels in Tewaukon Watershed commencing at 9:00 o'clock A.M. on the 6th day of May, 1966. All Commissioners voted in favor of this motion so the same carried.

Chairman Bosse then reported to the Board that ice had taken out several fences on Channel #1, Wild Rice Creek Watershed. A general discussion was held

concerning this matter.

It was thereupon moved by Commissioner Breum and seconded by Commissioner Bergsjoe that Urban Hoistad be hired at the hourly rate of \$1.60 per hour to repair all fences on Channel #1, Wild Rice Creek Watershed and Dam T-lA, T-7, and T-2, Tewaukon Watershed, and that he be authorized to purchase all necessary materials to do this work. All Commissioners voted in favor of this motion so the same carried and the resolution was adopted.

A discussion was then held regarding the Operation and Maintenance Agreement

MINUTES OF THE MEETING OF THE SARGENT COUNTY WATER MANAGEMENT BOARD HELD IN THE COMMISSIONER'S ROOM IN THE SARGENT COUNTY COURTHOUSE, FORMAN, NORTH DAKOTA, ON MAY 19, 1966, AT THE HOUR OF 9:30 O'CLOCK A.M.

The meeting was called to order by Chairman, Wm. Bosse. Present at the meeting were: Wm. Bosse, Ole Breum and Milton Bergsjoe, members of the Board; Robert A. Case, Secretary-Treasurer and Contracting Officer; Ed Kubler, Project Engineer; Ordean Jacobson, Work Unit Conservationist; and Harold Luke, Arthur Cratty and A. R. Moum of the State Soil Conservation Service.

Mr. Arthur Cratty then made a report to the Board concerning proposed Dam T-8, Tewaukon Watershed. He stated that this proposed dam would have the most floodwater detention of any dam in Tewaukon Watershed. He stated further that the dam site was located entirely within the State of South Dakota, and that all the easements would have to be secured from residents of the State of South Dakota.

He stated, however, that it was legally possible for this Board to secure easements for this purpose in respect to land located in another state. Mr. Cratty then suggested that the State Soil Conservation Service prepare a land rights map, that all necessary data dnd information be secured, and that after this was done that a meeting be arranged between this Board and the effected land owners residing in South Dakota; Mr. Cratty also stated that it would be possible to design the dam so there would be no sediment pool; that is, a 12 in. pipe coulc be used rather than a 8 in. pipe, with the understanding that the pipe could be opened at any time. The dam would then be in effect a dry dam.

If this were done, the difference in cost between a 12 in. pipe and an 8 in.

pipe would probably be a local cost.

It was thereupon moved by Commissioner Breum and seconded by Commissioner Bergsjoe that the State Soil Conservation Service Office be requested to prepare a land rights map in respect to Dam T-8, Tewaukon Watershed, and that all necessary and pertinent data and information be assembled in respect to this dam, and that after this was done that a meeting be arranged with all persons effected residing within the State of South Dakota, together with Soil Conservation Service personnel.

On roll call vote all Commissioners voted "aye" and no one voted "nay" so the

motion carried and the resolution was adopted.

Commissioner Bergsjoe then reported to the Board that he had been approached by a number of people from the City of Milnor, indicating that they were confronted with a serious drainage problem, and Mr. Bergsjoe asked the Soil Conservation Service personnel present to consider this problem. It was brought out that two projects known as "Storm Lake" and "Elk Creek" projects had previously been surveyed and considered by the Soil Conservation Service, but that no definite action had ever been taken in respect to either of these projects.

It was then agreed that a tour of this area be tentatively set for June 16, 1966. The matter of bids pursuant to Advertisement for Bids for the construction of

Channel Improvement #9, Wild Rice Creek Watershed, was then taken up.

Sealed bids, having endorsements upon the outside of the envelope containing each bid stating what the proposals were for, were on file with Mr. Robert A. Case, Contracting Officer, from the following persons and firms: Barnard Curtiss, Co., 1019 Soo Line Bldg., Minneapolis 2, Minnesota; Archie Campbell, New Rockford, North Dakota; Al Bergeron Co., Springfield, Minnesota; Platte Valley Construction Co., Clara City, Minnesota; Oscar H. Blumer, 1070 5th St., S.W., Valley City, North Dakota; Megarry Bros. Inc., 437 334d Ave. N., St. Cloud, Minnesota; and William Clairmont, Inc., Box 1074, Bismarck, North Dakota. Each bid was accompanied by a bid bond in an amount of not less than 20% of the bid. The bids were in the following amounts:

Case, Secretary-Treasurer and contracting officer; Ordean Jacobson, Work Unit Conservationist; and Oscar Wehlander and Eddie Friskop, Hall Township farmers; also present was Mr. Howard Bergeron, a representative of the Al Bergeron Construction Company.

A discussion was held with Mr. Bergeron regarding the leveling of a portion of the spoil bank on Channel No. 9, Wild Rice Creek Watershed and it was agreed that the spoil bank on the Otto Illig property would be leveled as soon as possible in order that the fence could be replaced. A further discussion was held with Mr. Bergeron regarding culverts and other matters relation to Channel No. 9.

It was thereupon moved by Commissioner Breum and seconded by Commissioner Bergsjoe that the Al Bergeron Construction Company be hired to remove, replace and install culverts on Township road one-half mile North of Al Dahl property, such work to be done on an hourly basis, as follows: \$20.00 per hour four dragline and \$18.00 per hour for bulldozer.

On roll call vote all Commissioners voted "aye" and no one voted "nay" so the motion carried.

The farmers from Hall Township then stated to the Board that they would like to have a drain constructed along the road ditch of highway No. 13, such ditch to run about $3\frac{1}{2}$ miles to the Richland County line. They stated further that it was their understanding that such a drain was being constructed in Richland County to drain waters into Elk Creek.

Mr. Jacobson then reported to the Board that he had been informed that the Richland County Water Management Board had contacted the State Highway Department about such a drain and had also contacted Mr. C. P. Nelson of the State Water Commission and that there was a possibility that the State Highway Department would pay the cost of constructing such a drain. Mr. Jacobson suggested that this Board meet with the Richland County Board and Mr. C. P. Nelson for the purpose of including the Sargent County area in the proposed drain.

It was thereupon moved by Commissioner Bergsjoe and seconded by Commissioner Breum that the Secretary contact the Richland County Water Management Board concerning a joint meeting to consider the matter of the drain along state highway #13 and generally to secure their cooperation in this undertaking. On roll call vote all commissioners voted "aye" so the motion carried.

It was moved, seconded and passed to adjourn.

The meeting was called to order by Chairman Wm. Bosse. Present at the meeting were: Wm. Bosse and Milton Bergsjoe, Commissioners; Robert A. Case, Secretary-Treasurer and Contracting Officer; and Ordean Jacobson, Work Unit Conservationist.

The minutes of the previous meeting were read and approved. A written financial report was presented to the Board and was approved.

Commissioner Bergsjoe then reported to the Board that he had attended a meeting at Wyndmere, N. Dak. on September, 27th, 1966, at which meeting the matter of constructing a drain along the South ditch of State Highway #13 near the Richland County line, was brought up. Commissioner Bergsjoe further reported that the following persons were in attendance at this meeting: Mr. C. P. Nelson of the State Water Commission, Mr. Zink, a representative of the State Highway Department, the members of the Richland County Water Management Board, the members of the Ransom County Drainage Board, Everett Stevens, a member of the Sargent County Drainage Board and Commissioner Bergsjoe; Commissioner Bergsjoe reported further that it appeared that Richland County had been given permission to construct a drain along the South road ditch of highway #13 but that permission would not be given to Sargent County to do the same.

A discussion was then held regarding the matter of hiring the Al Bergeron Construction Company to place spoil material from station 99+50 to station 122+50, Gan Channel #9, Wild Rice Creek Watershed, on the West side of the Channel for the purpose of constructing a private drive for Mr. George Kurth. It was suggested that said company be paid equipment rental rates as established by the State Highway Department, for this work, plus an additional 15% for profit and overhead; and that the total of these amounts be divided into the total amount of cubic yards of dirt involved to determine the cost per cubic yard. It was reported that the Federal Government would pay for the cost of this work to the extent that the cost thereof does not exceed 18¢ per cubic yard computed by the formula outlined above. (18¢ per cubic yard being the price for this type of work as outlined in the bid of Al Bergeron Construction Company on Channel #9). It was reported further that Mr. George Kurth would contribute a sum not to exceed \$200.00 towards the cost of such work, if the cost thereof exceeds the amount to be paid by the Federal Government.

It was thereupon moved by Commissioner Bergsjoe and seconded by Commissioner Bosse that the Al Bergeron Construction Company be hired by this Board to place all spoil material from station 99+50 to station 122+50, Channel #9, Wild Rice Creek Watershed, on the West side of the channel for the purpose of constructing a private drive for George Kurth and that this Board pay for all that part of the cost of such work in excess of the amounts paid by the Federal Government and Mr. George Kurth.

(It being understood and agreed that the said Company shall be paid equipment rental

rates as established by the State Highway Department, for such work, plus an additional 15% for profit and overhead and that the total of these amounts shall be divided into the total amount of cubic yards of dirt involved to determine the price per cubic yard; it being further understood and agreed that the Federal Government would pay for the cost of 18¢ per cubic yard and that Mr. George Kurth would contribute an amount not to exceed \$200.00 towards the cost of such work if the cost thereof exceeds the amount to be paid by the Federal Government.

On roll call vote all Commissioners voted "aye" so the motion carried and the

resolution was adopted.

It was thereupon moved by Commissioner Bosse and seconded by Commissioner Bergsjoe that this Board pay for and furnish one 40 ft by 24 in. culvert for the private drive constructed on the George Kurth property. On roll call vote all Commissioners voted in favor of this motion and the same carried.

It was thereupon moved by Commissioner Bosse and seconded by Commissioner Bergsjoe that the following bills be approved and paid:

The meeting was called to order by Chairman Wm. Bosse. Present at the meeting were: Wm. Bosse, Ole Breum and Milton Bergsjoe, Commissioners; Robert A. Case, Secretary-Treasurer and Contracting Officer; Ordean Jacobson, Work Unit Conservationist; Urban Hoistad, Robert S. Fischer and A. R. Moum, Soil Conservation Service Personnel; the following persons also attended the meeting: Maloy Norby and Densel Arneson of Havana, North Dakota; Mr. Donald Burnstad of the Burnstad Construction Company of Milnor, North Dakota; Mr. Howard Bergeron of the Al Bergeron Construction Co. of Springfield, Minnesota; and Clarence Breker of Havana, North Dakota.

The minutes of the previous meeting were read and approved. A written financial

report was presented to the board and was approved.

Commissioner Breum reported to the board that he had received a notice that the Association of Water Management District Boards would hold its annual meeting at

Carrington, North Dakota, on Friday, December 9, 1966.

A conference was then held with Mr. Maloy Norby, a farmer from Havana, North Dakota, who farms certain lands owned by the District on a 1/3 crop share basis. Mr. Norby told the board that he would like to purchase the board's one-third share of certain feed grain and corn raised furing the 1966 farming season as follows: 130 bushels of oats @ 50¢ per bushel or \$65.00; 5700 lbs. of millet @ \$1.80 per cwt. or \$102.60; 16 acres of corn @ \$5.00 per acre or \$80.00; and 360 bales of hay @ 25¢ per bale. Mr. Norby also agreed to pay \$1.00 an acre for 25 acres of pasture land; the total amount that he proposed to pay the district being the sum of \$362.00. It was thereupon moved by Commissioner Breum and seconded by Commissioner Bergsjoe that the Board accept the sum of \$362.00 from Mr. Maloy Norby as full settlement for the purchase of the board's one-third share of all 1966 feed grain and corn retained by Mr. Norby and for all pasture rent owed by Mr. Norby.

On roll call vote all commissioners voted "aye" and no one voted "nay" so

the motion carried.

A further discussion was held with Mr. Norby regarding the possibility of a cash rent lease for the 1967 farming season. Mr. Norby told the board that he would be willing to enter into such a lease upon the following terms: \$3.00 per acre for all crop land that he is farming (approximately 97 acres) and \$1.50 per acre for all hay and pasture land (25 acres of pasture land and 40 acres of hay land). No definite agreement was reached regarding a cash rent lease.

A short conference was then held with Mr. Densel Arneson, another farmer who is leasing certain lands owned by the District on a crop share basis. The possibility of a cash rent lease for 1967 was also discussed with Mr. Arneson, but no definite agreement was reached. Mr. Arneson also informed the board that he was somewhat dissatisfied with the texas crossing that has been constructed across Channel No. 2, Tewaukon Watershed and which is located on his property.

A conference was then held with Mr. Clarence Breker regarding a payment that the board had agreed to make to him for leaving a part of his farm idle in connection with the construction of Channel No. 2, Tewaukon Watershed. Mr.Breker told the board that he would accept the sum of \$218.00 in full settlement for the 21.8 acres that he left idle as a result of the construction of the channel. It was thereupon moved by Commissioner Breum and seconded by Commissioner Bergsjoe that Mr. Clarence Breker be paid the sum of \$218,00 for the 21.8 acres of farm land that was left idle as a result of the construction of Channel No. 2, Tewaukon Watershed. On roll call vote all Commissioners voted "aye" and no one voted "nay" so the motion carried.

A conference was then held with Mr. Donald Burnstad of Milnor, North Dakota, owner of Burnstad Construction Co. regarding a bill that he had presented to the board for excavating a texas crossing on Channel No. 2, Tewaukon Watershed. As a results of the conference Mr. Burnstad agreed to reduce his charges and present a new bill in the amount of \$95.00. It was thereupon moved by Commissioner Bergsjoe and seconded by Commissioner Breum that Burnstad Construction be paid the sum of \$95.00 for excavation work for a texas crossing on Channel No. 2, Tewaukon Watershed On roll call vote all Commissioners voted "aye" and no one voted "nay" so the motion carried and the resolution was adopted.

A conference was then held with Mr. Howard Bergeron of the Al Bergeron Construction Co. in connection with certain bill that were presented to the board for extra work done on Channel No. 9, Tewaukon Watershed; all of such work involving items that this board had previously agreed to pay for. It was thereupon moved by Commissioner Bergsjoe and seconded by Commissioner Breum that this board pay the Al Bergeron Construction Co. for extra work done in connection with Channel No. 9, Tewaukon Watershed as follows:

- 1. For moving dirt from East to West side of Channel for road (Station 100 to 123) the sum of \$285.06.
- 2. Setting pipe, George Kurth Crossing (Center of Section 20, Taylor Township) the sum of \$206.00.
