Meeting Minutes

Thursday, July 16th, 2026 at 8:00 a.m.

The Dickey-Sargent Joint Water Resource District met on Thursday, July 16th, 2026 at 8:00 a.m., in the water resource district board room at the Sargent County Courthouse in Forman, North Dakota. 2027 Budget:

The joint board went through the budget line items for both the Dickey-Sargent Improvement as well as the Dickey-Sargent Maintenance District. Manager Zetocha made a motion to approve the proposed budget, with a second from Manager Wyum. Upon roll call, the motion carried unanimously.

A motion was made by Manager Wyum to set the per acre assessment fee to \$2.50/acre. Manager Stein seconded this motion. Upon roll call, the motion carried unanimously.
